

FIRM TONE CONTINUES IN HOG MARKET

There continues a firm tone in the hog market at North Portland, with sales substantially at Wednesday's prices. For top sales were shown at \$9.70@9.75.

There was only a small run of hogs in the yards at the opening of the day's trade, and sales were made more prompt than on recent days.

Depression was again general in the world's wheat trade for the day. Recent trading has been very erratic, being firm and higher one moment and

weak and lower the next. This feeling is naturally shared to some extent by the local trade, although it must be said to the credit of Pacific northwest wheat buyers, they have been far less stampeded by the recent downward fluctuations elsewhere than has been the case in other sections.

To some extent perhaps this is due to the fact that the moment that prices go off a fraction here, selling in the country is entirely suspended.

What has happened to the barley market is at present a mystery in the grade here. There has been practically no trading in barley at Pacific northwest points of late, although stocks are short. Relatively speaking, oats are really cheaper than barley, and this may be one of the solutions of the mystery. With plenty of oats offering at the lower prices, there is naturally much less indication to take hold of barley at the higher figures.

OREGON TROOPS TO BE MUSTERED OUT MONDAY

Third Oregon Infantry Will Immediately Resume Existence as Third Regiment Oregon National Guard.

PORTLAND, Sept. 22.—Monday morning, September 25, at 9:30 o'clock the Third Oregon Infantry will be mustered out from the federal service at Camp Withycombe. The regiment will immediately resume its existence as the Third regiment Oregon national guard, nearly all the men having taken the new oath provided by the federal military law.

The next time it is called out there will be no need of any new oaths of allegiance or mustering into the federal service, as was the case when the last call was made by President Wilson on June 18. The regiment will resume its existence as the infantry organization of the O. N. G., and be under the same officers as now. Hereafter the president of the United States can call it out with less delay and expense than was possible under the old law.

Immediately after the mustering out under command of Captain K. P. Williams, there will be payday for every man and officer, and that will terminate the relations as federal soldiers until the Third Oregon is called again by Uncle Sam.

NEW YORK, Sept. 22.—Officials of the Industrial Workers of the World announce their decision to call upon labor organizations to declare a general protest strike during the week of the trial of Carlo Tresca and other strike leaders of the Minnesota I. W. W. iron miners, to enforce a demand for a fair trial. National officials of the I. W. W. claim to have the pledge of the support and co-operation of Italian Socialists, Anarchists and labor organizations and a large number of Italian publications.

Raimondo Fazio, of the general strike committee, and editor of one of the official organs of the I. W. W., said that the general strike will be called as soon as the trial of the Minnesota iron miners, which is expected soon begins.
