The Twelfth Federal Reserve Bank has sent a cir-cular potice to all banks in the district, announcing that it will look with disfavor on all non-essential credit paper during the progress of the war. Non-essential means of course non-war casential.

"Preparations are being made for government regulation of credit for corporate financing, intend-ed to restrict or discriminate against credit for nonessential purposes," reads the letter. "The restric-tion or limitation of credit for other non-essential purposes is quite as necessary and may, at any time, be placed under government regulation, but this dis-crimination should be immediately initiated and vol-untarily applied by banks whose opportunity for such discrimination is immediate. In order to meet the requirements of the government we must have con-servation of credit as well as conservation of food, When this war crisis is past bankers may again properly say, 'It is my first duly to care for my cus-


