WASHINGTON, Feb. 21.—Senator Sherman introduced a resolution requesting President Wilson not to discuss the league of nations at Boston.

COSSACK FORCE PUTS BOLSHEVIKS TO ROUT

SENATE PASSED BOND BILL; FOUR VOTED AGAINST

Ten Million Dollars in State Money Will be Available for Highway Work.

SALEM, Feb. 21.—Oregon's \$10,000,000 road bonding bill is now ready for the signature of Governor Withycombe.

After 2 1/2 hours of debate Thursday afternoon, the bill, which is house bill 427, was passed by the senate with only four votes against it.

Emergency Clause Remains.

Combined with the desire for improved roads, the legislature passed the big bonding bill with an emergency clause attached as one step to meet an unemployment emergency which is a serious problem of the reconstruction period following the world war.

BREST, Feb. 21.—Mothers of Americans who are waiting for their boys to come home may rest assured that Brest is not a "nest hole."

Brest was selected as the chief port for the arrival of American troops in France primarily because it is the closest to the United States and dangers of submarines and mines are lessened in consequence.

VOTE OF PEOPLE ON LEAGUE DEMANDED

WASHINGTON, Feb. 21.—Senator Foran speaking in the senate, today demanded that the Americans be given a vote on the league of nations constitution before the government binds itself under the compact.

HOUSE JAMMED WITH BILLS; ADJOURNMENT EXPECTED BY EARLY WEDNESDAY MORNING MANY MEASURES ACTED ON

SALEM, Feb. 21.—With the desk jammed with unfinished senate business, including the big appropriation bills, the house has resigned to the necessity of adjourning Saturday night until Monday.

\$5,000,000 BILL PASSED.

The senate with decks clear is marking time, working only part of the day. The senate today passed the five million reconstruction bond issue constitutional amendment, also a bill providing for the expenditure of three millions of the issue on the reconstruction program.

HIGH MEMORIAL KILLED.

The senate killed a memorial urging Wilson to use his influence for home rule for Ireland.

CASCADES BILL DEFEATED.

The senate killed a bill appropriating \$10,000 for investigating the Columbia river at Cascades so as to improve river shipping.

PRESET LAWS GOOD.

The house killed a bill prohibiting

prostitution on the ground that present laws are sufficient.

OREGON LABELS REQUIRED.

The house passed a bill requiring Oregon labels on Oregon products, and a bill creating a bird reserve out of Malheur lake.

The senate passed a resolution referring a constitutional amendment providing for consolidation of the Portland and Multnomah county governments.

VETERAN'S PROPERTY EXEMPT

The senate passed a bill exempting the property of civil war veterans up to the value of \$2500 from taxation.

\$400,000 HOSPITAL.

The industrial accident commission was authorized by the senate to expend \$400,000 of its accumulated surplus on a reconstruction hospital in Portland. The commission now has a million surplus.

\$150,000 FOR PENDLETON.

The reconstruction bond bill passed today provides \$150,000 for the Pendleton hospital.

GENERAL STRIKE IS RAGING IN GERMANY

BASEL, Feb. 21.—The general strike and attendant disorders are increasing in Germany, a dispatch today indicates.

After the Spartacists cut the railway from Eberfeld to Spa, government troops arrived at Eberfeld and defeated the revolutionists, killing 17 and wounding 28.

The Spartacists have occupied Bayreuth, forcing the burgomaster to resign. Government forces are being concentrated south of Lippe and east of Bochum.

Want Government Overthrown.

BERNE, Feb. 21.—Communist coal miners in the Ruhr district have resolved not to return to work until the present German government is overthrown, according to the Frankfurter Zeitung. The strikers now total 120,000.

Rioting in Munich.

BERLIN, Feb. 21.—Mutinous sailors and government troops clashed at Munich when 60 sailors, armed with hand grenades, attacked the building in which the Bavarian council was sitting, dispatches today assert. The sailors retreated after two were wounded.

Gov't Troops Take Buildings.

BASEL, Feb. 21.—German government troops operating with Marshal Foch's permission recaptured from the Spartacists all the Eberfeld public buildings, according to a dispatch today.

The fighting continued until noon yesterday, the troops withdrawing and leaving a guard to maintain order in agreement with the allies. (Eberfeld is within the neutral zone, east of the Rhine.) The Spartacists are reported to have seized \$1 million gold in the Reichsbank of Muelheim.

LIQUOR RUNNERS SWAMPING TOLEDO

TOLEDO, O., Feb. 21.—Liquor stocks are practically depleted, hotels are packed and saloon employes are exhausted after two days of business with the Michigan liquor runners. Dealers' receipts are thirty to thirty-five thousand daily. It is estimated two million quarts have been taken to Michigan since the bars were let down.

Declared Illegal.

TOLEDO, Feb. 21.—Judge Root, of Monroe, Mich., granted an injunction preventing any person from carrying liquor into Michigan on the grounds that it is against the constitution and dry laws of the state. State constabulary officers and deputy sheriffs were sent to the state line to arrest all liquor runners.

750 MILLION FOR R. I.

WASHINGTON, Feb. 21.—The house today passed a bill appropriating 750 million dollars for a railroad administration revolving fund by a vote of 272 to 15.

LABOR DIFFICULTIES GREATEST IN HISTORY

WASHINGTON, Feb. 21.—Labor difficulties are probably more prevalent now than at any time in the nation's history, labor department reports show. At the same time thousands are striking, other thousands who want work cannot find employment due to the general stagnation of industry.

HIGHWAY COMMISSION AWAITS ACTION HERE

Prompt Co-operation by State Assured if County Bond Issue is Adopted.

The passing of the 10 million dollar road bond bill by the senate yesterday assures the co-operation of the state with Umatilla county if the local bond issue carries. With the view of getting quick action if the election carries in the county, W. L. Thompson, acting chairman of the state highway commission, stated today that he had postponed the next regular meeting of the commission from March 4 to March 6.

"This is to permit the commission," says Mr. Thompson, "if the local bond issue carries, to arrange at once for letting contracts for paving the road between the Washington state line and Milton and for the work from Echo to the Morrow county line. As the engineering features of these two jobs is now almost complete they can be taken up at once."

For Early Paving.

Other work outlined in the local bond issue will be carried out if it carries as rapidly as the paving. The part between Eastland and Milton, as this road can be made ready for paving. The changes in alignment for the road are not so great as in other roads. This work should be followed rapidly by that of other parts of the program.

"The whole state of Oregon has its eye on Umatilla county in the bond election," says Mr. Thompson. "Other counties are prepared to vote bonds along the same lines, realizing that the highway commission will naturally favor in their order of road work those counties which are prepared to spend their part, as will be the case with Umatilla county if the bond issue carries."

TOWNS WILL HAVE HOLIDAYS MARCH 4

The desire that a large vote be polled at the road bond election here prompts the suggestion that mayors of the incorporated towns of the county declare a partial holiday the day of the election, March 4. Employees will in this way be given opportunity to vote.

The desire to get a full expression of the voters was the keynote of the meeting yesterday afternoon of the bond campaign executive committee. It was pointed out at the meeting by Secretary Straub that no opposition to the bonds has been shown from any part of the county, and the great danger is that there will be a light vote. Every possible effort will be made to get out a full vote, the idea being not to influence the vote, but to see that everybody votes.

MAY NEED MORE TROOPS.

LONDON, Feb. 21.—Viscount Peel, under secretary of war, announced in the house of lords last night that if the bolshevik offensive continued in northern Russia it would be necessary to reinforce allied troops.

EXPECT WILSON TO SAIL AGAIN MARCH 5

WASHINGTON, Feb. 21.—The presidential ship arrives in Boston Monday, Secretary Daniels announced today. President Wilson plans to sail again for France about March 5, Daniels added.

Asks Brief Ceremony.

The navy plans an aerial demonstration when the president arrives off the New England coast. President Wilson requested that the ceremony at Boston in his honor be brief on account of the necessity of his early return to Washington.

SINN FEINERS AGAIN ACTIVE IN IRELAND

DUBLIN, Feb. 21.—Sinn Feiners are reported today to have resumed activity throughout Ireland. A congress composed of delegates from Sinn Fein clubs from all parts of the country are said to be meeting secretly here.

Government authorities today raided the royal school at Rappoe seizing great quantity of rifles and 17,000 rounds of ammunition belonging to Ulster volunteers.

PRESBYTERIAN PASTOR TO ARRIVE TOMORROW

The Rev. J. Francis Morgan, D. D. the new pastor for the Presbyterian church, is expected to arrive in Pendleton tomorrow on No. 17. He comes to Pendleton from Jersey City, N. J.

BAVARIAN PREMIER IS ASSASSINATED

AMSTERDAM, Feb. 21.—Kurt Eisner, Bavarian premier, has been assassinated according to a Munich dispatch. It said he had been shot by a lieutenant who was fatally wounded by the guard.

RESTORE MATERIAL TO FRANCE, BELGIUM

BASEL, Feb. 21.—A Weimar dispatch says the German national assembly has decided that industrial material taken from France and Belgium must be returned.

ASSASSINS HAD PLANS TO GET WILSON ALSO

Plots Said to Have Originated in Switzerland and Reported as Discovered.

FRENCH PREMIER IS RECOVERING EASILY

Tiger of France Hopes to be Out in Four or Five Days.

PARIS, Feb. 21.—Rumors are circulating here that several plots have been unearthed in Switzerland and are regarded as a part of the program of extremist conspiracies, in connection with the attack upon Clemenceau.

Clemenceau Recovering.

PARIS, Feb. 21.—Premier Clemenceau will be out of danger in 48 hours, it was announced this morning. "I am very optimistic of my ability to return to work in four or five days," he told President Poincare.

It is announced at the premier's residence that he is getting on as well as possible. He was out on the balcony for a while yesterday. Considering the relative gravity of the wound his condition is regarded as highly satisfactory. It is announced both his pulse and temperature are practically normal.

Meeting at Residence.

PARIS, Feb. 21.—A meeting of the supreme war council this afternoon will be held at the residence of Premier Clemenceau. This is accepted as revealing an optimistic feeling regarding the premier's condition.

SHIPPING BOARD TO HANDLE STRIKERS

WASHINGTON, Feb. 21.—Shipping board officials today denied they would permit the war labor board to handle the Seattle strike shipbuilders. Until the shipping board's own organization—the Macy wage board—goes out of existence April 1, Chairman Pies said the emergency fleet and shipping board will handle its own labor disputes.

DENIES IMPROPER CARE IN ARGONNE

WASHINGTON, Feb. 20.—Charges that the 35th division was mishandled and improperly cared for in the battle of the Argonne are not "well founded," General Traub, division commander, told the house rules committee today. He said: "Everything possible was done for the wounded."

He flatly denied that the Germans would enter the air. He admitted a shortage of horses but denied it was as great as 52 per cent. Unavoidable in Battle. Questioned concerning the charges of Governor Allen of Kansas, Traub either made a flat denial or said the condition was unavoidable under the exigencies of battle. He admitted there "were not enough stretchers in the A. E. F. to take care of 7000 men at one point."

Turning to the artillery, the general declared that about half a dozen shells from allied artillery fell inside the American lines. He maintained soldiers always had something to eat although there was probably a shortage of food at some points.

He explained that supplies of winter underclothing had not caught up with the division at the time of the Argonne fighting. Engineers Fought. Engineer troops had been pressed into fighting to relieve the infantry division. He admitted, "and you can not expect life they fought too. The Boche had the Frenchmen's coat. He would not go up there and try that job. We took in three hours, when the Boche had been up against for three years."
