DECISION IN HAWLEY DIVORCE CASE IS NOW IN HANDS OF JUDGE

Oregon City Legal Battle Closes
With Return of Both Principals to Witness Stand on Rebuttal; Evidence Massive.

OREGON CITY, Ore., March 1.—Judge George R. Bagley holds in his hands the final disposition of the divorce suit of Marjorie Hawley vs. Willard Hawley, Jr., which has occupied his attention for the last two weeks and which came to a close Friday afternoon.

After the conclusion of a three hour argument, Judge Bagley took under advisement the thousands of words of testimony, the several depositions and the exhibits that make up the record of the case that has attracted statewide attention. His decision may be delayed for weeks, because of the mass of evidence involved.

Both principals were on the stand on rebuttal and Marjorie Hawley reiterated her former statement that she had thrown a Worcestershire sauce bottle on the floor with sufficient force to break it when Willard made a remark that reflected upon her chastity prior to her marriage.

"That same evening I telephoned my sister, Mrs. Ball, at Portland about leaving Willard," testified the plaintiff. "I had my grip packed all ready to go. That was the evening he took against the sink and told me he was going to the home of his parents and take my baby. I threatened to call sheriff."

"You just dare to stir up a stink about me," said Willard, according to his wife's statement. "It broke my heart to think he would question my chastity," continued the witness, who said the allegations in her husband's complaint upset her dreadfully because they were untrue. She declared the dress she has been wearing in the court room that has been the subject of so much criticism was a gift from Willard and a peace offering after the argument in which the Worcestershire sauce bottle figured, when Marjorie said Mr. Hawley had threatened to throw her out of the house. She said Willard sent her to Portland to buy the dress and a hat. The argument had occurred at the lunch hour.

KREIGER GETS DECISION OVER HARDY BUT FANS BELIEVE LATTER WON

Four Fast Matches at Legion
Affair Saturday Night Please
Large Crowd of County's
Former Service Men.

Henry Kreiger was awarded an unpopular decision over Harry Hardy after six rounds of milling at the American Legion smoker Saturday night in the main bout of the evening. The decision was turned in by a committee of three judges and was met by howls and hisses, so certain was a large part of the crowd that Hardy had won. Ralph Shaw refereed the matches but was not responsible for the decision, it having been left to the city boxing commission.

Both boys gave a good exhibition before the 500 legion men present from all over Umatilla county. Both were out to win and while the battle satisfied everyone, the decision was not popular.

Buddy Stevens and Ed Williamson, both local boys, boxed a fast four round draw in the semi-windup of the evening. Andy Jensen, of Walla Walla, was awarded a decision over Kid Williams, local lightweight, in a clever four-round go. The fans were strong for Jensen's work and the decision was popular.

Ray McCarroll, local wrestling demon, disposed of both Louis Gensack and Ed Hayes in less than 10 minutes in the opening event of the evening. McCarroll was in good form but heavy and declares he will come down several pounds before engaging further bouts.

Young Whitey and the Masked Marvel opened the boxing program for the evening with four rounds of boxing, with a shade for the Masked Marvel. He is a Freewater man.

Musie by the local legion orchestra and a general smoker and mixer helped make Eagle-Woodmen hall an interesting spot Saturday night. The event was not on by Pendleton Post as a finale to a week of campaigning for members. All posts in the county entered the recruiting drive and many of those present at the smoker were men affiliated during the week. It is something that the local post will stage something of a similar nature at a later date.

TOKIO WILL INAUGURATE TRIAL BY JURY METHOD

TOKIO, March 1.—Premier Hara, in a speech before the diet, announced a coming increase in the income tax and a tax on sake; a bill for the reform of the local governmental system; the introduction of a system of trial by jury, and an increase in the strength of the Japanese navy.

Premier Hara declared the recent sending of additional troops to Siberia was not prompted by territorial ambitions.

Speaking of the Chinese question, the premier said it is the intention of the Japanese, by degrees, to be clearly understood by the Chinese. Chinese agitation against the Japanese, he asserted, is inspired by misunderstanding on the part of some Chinese.

Viscount Uchida, the foreign minister, in his speech, referred to the league of nations covenant as the "Magna Charta of the new world."

"Japan has on no occasion failed to carry out her international engagements in the past and it goes without saying that she will be one of those states which will strictly carry out every term of the present peace treaty," he said. "It is a source of profound gratification that the bond of our alliance with Great Britain is as strong as ever."

CAVALRY UNIT PLACED AT CORVALLIS SCHOOL

OREGON AGRICULTURAL COLLEGE, Corvallis, March 1.—A cavalry unit which may be limited to 50 men will be established at the Oregon Agricultural college immediately. Captain Copley Enos of the United States cavalry having arrived to take charge of the work. This unit will be in addition to the infantry, field artillery, engineer, motor transport, and signal corps units now in operation. Membership will be limited to freshmen and sophomores.

The horses now used by the field artillery unit will also be used by the cavalry, but saddles and other equipment will be sent here especially for the new unit. The equipment will not arrive for six weeks or after the beginning of next term and theoretical work will be followed until that time.

"OVERALL BRIGADE" IS INITIATED BY ALBANY POST OFFICE WORKERS

ALBANY, Feb. 28.—White collars, tailored suits and similar habiliments will no longer adorn the persons of the male clerks employed in the local postoffice if the plans for the "overall brigade" initiated here mature. Following the plan of the corduroy clubs, organized in California, the clerks in the postoffice who are backing the organization here plan to wear overalls while performing their duties until prices of clothes have lowered to a more reasonable scale.

CONVICT GOES ON VISIT RETURNING VOLUNTARILY

EFFORT TO HIDE VOTE LOSES 3500 BALLOTS

SEATTLE, March 1.—Between 3500 and 3600 who voted at the primary election on February 17 did not vote at all, according to estimates made by city comptroller Harry W. Carroll and his chief deputy, James H. Agnew. Although the 3500 or 3600 left the polling booths and voting machines serenely confident that they had cast their votes for Caldwell, Fitzgerald or Duncan, the fact is that a desire to keep their votes a deep secret from voters who followed them into the booths resulted in nullification of their ballots.

In a nutshell the act that lost between 3500 and 3600 majority votes was this: A voter, fearing that the man or woman who next followed him would see how he voted on the majority contest, would pull down the pointer over the name of Fitzgerald, Caldwell or Duncan, and then push it up again before he swung the lever which automatically registered the voter's wish.

While the "lost votes" for mayor probably would have no effect on the outcome, voters will be warned by the city comptroller not to pull the "pull-and-push" stunt with the pointers at the general election Tuesday.

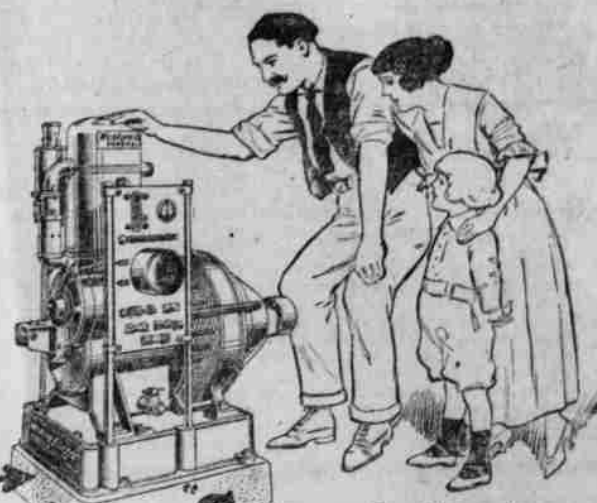
Cornell and Columbia oarsmen already are hard at it, although the spring regattas are months off. Under Charles E. Courtney, who at seventy is running rowing at Ithaca with his old-time vigor, the cadets are getting down to work on the machines with keen enthusiasm. Work has just been resumed by Columbia's veteran coach, Jim Rice, who says that the reduction of the distance at Poughkeepsie from four to three miles will not shorten the training period of the Blue and White for the intercollegiate regatta. He will give special attention to the "polyswog" in the swimming pool until the crews move to their Harlem River quarters in the spring. The varsity crew will go to Poughkeepsie on June 7. It is considered likely that Courtney will turn out one varsity crew for the two-mile race, one with Yale and Princeton and the other with Harvard and another developed exclusively for the three-mile race at Poughkeepsie. He has nearly ninety candidates.
