Dr. Hindley to Come. An invitation to deliver an address before the membership of the Pendleton Commercial Association, which was extended him recently, has been accepted by Dr. W. J. Hindley, formerly mayor of Spokane. Dr. Hindley is now director of the bureau of education of the Washington State teachers' association, and he is reputed to be one of the keenest students of business and economic problems in the Northwest. The time of his address has not yet been set, but it is thought he will come within the next three weeks. Present plans are that he will be heard at an evening meeting.

While in Portland Mr. Matlock expects to purchase chairs for his new theater.
