LONDON JURIST PLANS ENGLISH DIVORCE LAW

LONDON, Nov. 29.—A strike by divorce judges, until the tedious and complicated divorce laws of England are corrected, is advocated by James Dodd, an eminent jurist, in a paper read before the Law Society.

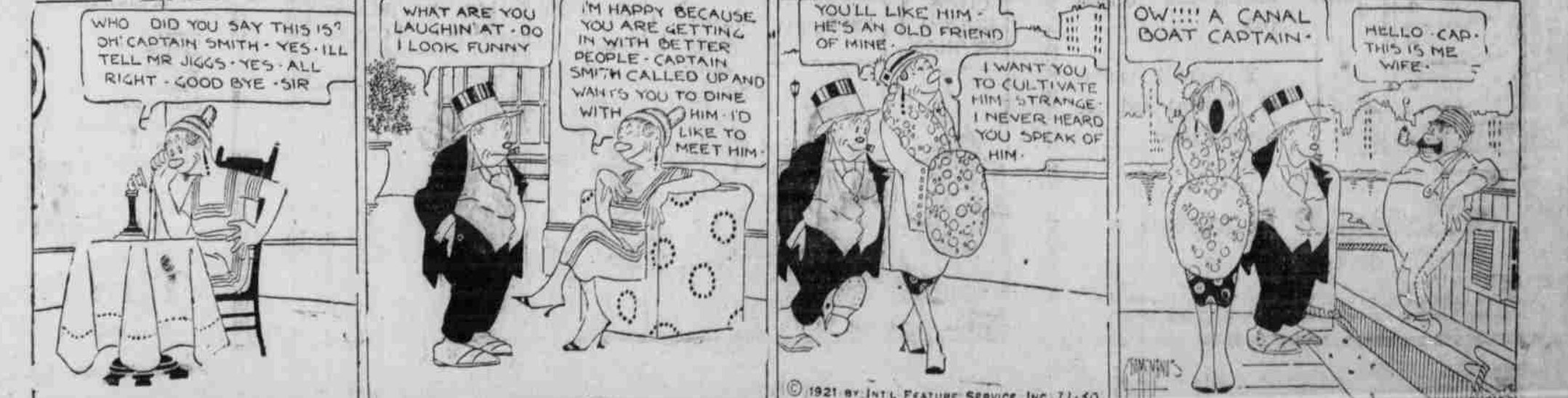
If only the divorce judges would go on strike they might get something done toward clearing away the mystery and perjury that has made the divorce court an abomination, Dodd declared.

Before a divorce may be petitioned for in England there must be a petition for restitution of conjugal rights. It must be shown that the party bringing the suit has proposed to the other party in the case a return to the relations of marriage, and that the second party has refused and that there has been desertion for two years.

Then comes the petition for divorce, with another long delay. The cost is appalling, and no good purpose is served by it.
