# Second person dies from I-84 traffic crash

A second person has died from a traffic crash April 26 on Interstate 84 near Meacham.

Bryan Yeager, 53, of Elgin, was initially flown to Kadlec Regional Medical Center in Richland with critical injuries and later transferred to Oregon Health and Science University in Portland. Yeager died May 4 at OHSU.

Yeager was a passenger

in the vehicle driven by Steven Gardner, 60, of Cove, who crashed at about 2:13 a.m. on the interstate at mile post 238. According to Oregon State Police, the vehicle was traveling eastbound when it lost control and went across the median, striking a guardrail and rolling onto its top.

Gardner was pronounced dead at the scene. The cause of the wreck is still under investigation by the OSP Pendleton Area Command.

# Hermiston gathers local feedback on landscaping ordinance

A proposed ordinance working its way to the Hermiston City Council would require all new commercial, industrial and multi-family residential development to be landscaped in a way that meets the city's approval.

The ordinance leaves

the exact design up to developers, broadly requiring "a combination of deciduous and evergreen trees, shrubs and ground covers." But it does require that developers landscape a certain percentage of their property and get the plans approved through the granting of a city landscape permit.

At an open house Thursday night Hermiston resident Kathy Erz said the ordinance would unfairly burden business owners with extra costs to water, mow, trim, weed and otherwise maintain the landscaping.

I understand people want a beautiful city. I do," she said. "I've lived here all my life. But you can't force it."

Stacey Stanek agreed. She said as the city increased water and electricity costs, requiring business owners and property managers to put in plants and decorative lighting could end up being a deterrent to development.

"It's just another cost on business owners," she said.

planner Clint City Spencer said the ordinance was originally developed the Community Enhancement Committee at the request of the city council. As part of its mandate to increase Hermiston's beautification and livability the committee came up with a list of rules it would like to see implemented. The list was then passed on to the planning commission for development as a land use ordinance.

Assistant city manager Mark Morgan said the

next step would be for city staff to take the ordinance, along with public feedback, to the city council, probably in June.

"They're the ones who asked for it," he said.

The council would go through an official public hearing process before voting on the ordinance.

As written, the rules require 15 percent of the site of a new multi-family residence to be landscaped, 3 percent of the site in a central commercial zone. six percent of the site in an outlying commercial zone and three percent of the developed area of an industrial zone development.

Sites in the downtown commercial overlay have more flexibility and are allowed to use decorative lighting, benches and other features where planting grass or trees isn't feasible.

In other zones, however, plants must make up the majority of the landscaping and developers must submit a plan for irrigation of plants that are not drought-tolerant.

To go along with the ordinance the city has also developed a set of guidelines with suggests the types of plants, ground cover and designs that work best for the area.
