Harper Llewellyn Jones DDS MS

Harper Llewellyn Jones passed away on November 26, 2015, from natural causes.

He was born on March 8, 1925, in Great Falls, Montana, to William Harper Jones and Miriam Callaway. He moved to Helena, Montana, at an early age and graduated from Helena High School in 1943. He was fond of telling stories of growing up in Helena and recounting the mischief he and his childhood friends would cause.

He enlisted in the Navy in 1943 in the V5 program. He was to be trained as a pilot but the Navy eventually had other needs for him. He finished the war as a fleet radioman in Mississippi and then was transferred to Minneapolis, Minnesota, when it was discovered he could type. He spent the next year mustering men out of the Navy and eventually returned to Helena when he was released from the Navy in 1946. He returned to life in Helena and using the GI Bill he attended and graduated from Carroll College with a Bachelor of Arts degree in biology and biochemistry. While visiting with some friends in Missoula he met a young lady named Arleathe (Lea) Marie Zuelke. They were married on October 11, 1952, in Helena.

Harper applied to the Loyola Dental School in Chicago and was accepted for entrance in the fall of 1954. Graduating in 1958, Harper and Lea returned to Helena where Harper worked as a dentist for the next 8 years. Their three children were born in Helena.

Harper decided to become an orthodontist, which required 2 more years of school and a move to Wisconsin to attend Marquette University. He graduated in 1968 and

contemplated a move back to Helena yet did not due to potentially competing with his Uncle Walter, also an orthodontist, whom he admired. A former dental school classmate, John McBee, contacted Harper and the move to Pendleton, Oregon, followed. Harper and Lea raised their children in Pendleton. Over the years Harper served the community in many ways. He was active in Kiwanis and served as the chairman of the Airport Commission for years. He was president of the Oregon Pilot's Association local chapter and professionally served as president of the Oregon Society of Dentistry for Children. He earned a pilot's license in

order to combat a fear of flying that had developed over the years. He flew all over the Northwest with his family and also would ferry friends when the need arose. He was an avid skier throughout his life and dearly loved traveling to Hawaii with his family. Harper is survived by Lea, his wife of 63 years; a brother Beezie (Sandy); his sons Harper II (Kimberley) and Wells (Merika); daughter Jean Watkins (Brian); and two grandsons and four granddaughters. He will be dearly missed.

There will be a rosary at Burns Mortuary of Pendleton on December 3rd at 7:00 p.m. followed on Friday, December 4th by a funeral mass at 10:30 a.m. at St. Mary's Church in Pendleton; interment will follow at Olney Cemetery.
