## Lee’s pin lifts Bucks over Baker

BAKER CITY — The Pendleton wrestling team earned a tense one-point victory over Baker in a non-league dual on Tuesday.

The lead changed hands three times with the Buckaroos’ Greg Lee giving his team a 37-36 victory with a pin in the last bout of the match.

Pendleton began the match with an 18-0 head start due to three Baker forfeits, but lost the first four contested weights to fall behind 20-18 when Baker’s James AhHee pinned Alex Rendon at the 126-pound class.

**B**rendon Bedolla briefly put the Bucks back on top with a 4-2 win over Nick Blair at 132 pounds, but 138-pounder Marco Vela answered for the Bulldogs with a pin over Shawn Yeager to make it 26-21 Baker.

Baker would hold on to that lead as the teams split the next four bouts and went into the 182-pound bout up 36-31.

That was where Lee stepped in with his pin over G’ovi Quezada to give the Bucks their second-straight dual win and raise the team’s record in duals to 5-1.

Three exhibition bouts also were wrestled on Tuesday with the Bucks going 2-1 in those with victories by Koby Jones (120 pounds), 10-5, and Aiden Patterson (126), 9-7.

Pendleton wrestles its final dual of the season tonight against Hermiston at 7 p.m. in Pendleton.

# OSAA executive director announces retirement

WILSONVILLE — Oregon School Activities Association (OSAA) executive director Tom Welter announced this week that he will be retiring from the organization effective July 31.

He began his OSAA career in 1995 as an assistant executive director and was promoted to his current position in 2001 when he succeeded Wes Ediger.

Among his accomplishments during his 15 years leading the association are establishing the OSAA Foundation and the Oregon Athletic Officials Association, and transitioning the OSAA from four to six classifications.

Welter, 67, also serves as president of the board of directors for the National Federation of State High School Associations (NFHS). His four-year term on the NFHS board concludes in July.

Born and raised in Stayton, Welter attended Regis High School and Oregon State University.

He coached several sports at Central Catholic High School beginning in 1974 and went on to serve as the school’s athletic director for 18 years and vice principal/dean of students for 15 years. He is a member of the Central Catholic Hall of Fame and was named Oregon Athletic Directors Association (OADA) AD of the Year in 1993 and presented with the OADA Lifetime Achievement Award in 2010.

# Vickers to replace Stewart at Daytona

DAYTONA BEACH, Fla. (AP) — Brian Vickers is expected to replace injured driver Tony Stewart for the NASCAR season opener at Daytona International Speedway, a person familiar with the decision told The Associated Press.

Stewart-Haas Racing has scheduled a Friday news conference to discuss its plans for the No. 14 Chevrolet. The person spoke on condition of

anonymity Wednesday because the team is awaiting word from NASCAR on whether Vickers is medically cleared to race.

Vickers ran only two races last season before having a recurrence of blood clots. He can’t compete when being treated for the clots because the blood thinners increase his risk of serious internal bleeding if he crashes.

Stewart is sidelined for the start of his final NASCAR season with a fractured vertebra. He was hurt riding an all-terrain vehicle in the desert

in California last week.

Vickers is only expected to run at Daytona, which opens Friday ahead of the Feb. 21 season-opening Daytona 500. SHR is still looking at all of its options for beyond Daytona. Stewart is expected to race at some point this year.

Vickers has been sidelined four times for health issues since 2010.

He missed the final five races of the 2013 season because he was placed on blood thinners to treat a blood clot in his right calf.

# Curry flirts with triple-double as Warriors win

PHOENIX — Stephen Curry nearly had a triple-double before sitting out the fourth quarter, and the Golden State Warriors stormed into the All-Star break on an 11-game winning streak with a 112-104 victory over the free-falling Phoenix Suns on Wednesday night.

Curry had 26 points, nine rebounds and nine assists for the defending NBA champions. At 48-4, the Warriors have the best record through 52 games in NBA history, one win better than the 1995-96 Chicago Bulls and 1966-67 Philadelphia 76ers. Those Bulls finished the season with a league-record 72 wins.

Klay Thompson added 24 points for Golden State.

Golden State was up by as many as 22 points in the second and third quarters, but the Suns cut it to 11 late in the third and 10 a couple of times in the fourth. The only time Phoenix got within single digits in the second half was on Goodwin’s breakaway dunk just before the final buzzer.

Warriors: Curry sank a 3-pointer for the 123rd consecutive game, four shy of Kyle Korver’s NBA record. ... Curry has seven career triple-doubles, two this season. ... Golden State comes out of the All-Star break with six straight road games. ... The Warriors have won six straight in the series.
