Thompson beats buzzer, lifts Beavers

CORVALLIS — Stephen Thompson scored 18 points, including a game-winning 3-pointer just before the buzzer, as Oregon State defeated Washington 82-81 on Wednesday night.

Oregon State inbounded the ball with 3.3 seconds left, trailing by two, as Thompson went the length of the court and heaved up a contested shot from the 3-point line. He appeared to shuffle his feet prior to the shot but it was not called.

Drew Eubanks added 17 points with 13 rebounds, Gary Payton II had 15 points, 10 rebounds and five steals, and Tres Tinkle scored 16 for the Beavers (16-10, 7-8 Pac-12).

Thompson, a freshman, also gave the Beavers a 71-69 win against Utah on Feb. 4 when he was fouled on a half-court shot as time expired and made all three



free throws.

Andrew Andrews scored 30 points and matched a career-high with six 3-pointers for the Huskies (16-12, 8-8), who have lost five of their last six. Dejeunte Murray scored 15 points and Marquese Chriss had 14 points.

The Huskies had a 77-72 lead with 2:25 left.

A Eubanks layup trimmed the Huskies' lead to 79-75 with one minute remaining. The basket was the Beavers first field goal in about nine minutes. Washington turned the ball over on its next possession and Tres Tinkle made a contested shot with his toe on the 3-point

line with 22 seconds left for the Beavers.

Crisp was fouled with 20.5 seconds left and made 1 of 2 free throws for an 80-77 lead.

Payton inbounded the ball to Tinkle, but officials ruled Tinkle was fouled before he could shoot. He made both free throws, and Andrews was fouled.

Andrews made 1 of 2 at the stripe, and the Beavers inbounded the ball to Thompson.

Kubiak: No rush for Manning to make decision about future

Denver coach Gary Kubiak says he's been in contact with Peyton Manning but isn't pressuring him for a decision about his future. He also made it clear he wants Brock Osweiler back under center for the Broncos next season.

Fifth-year backup Osweiler went 5-2 when Manning was hurt last season and is set to become a free agent next month.

Osweiler led the Broncos to crucial comeback wins over New England and Cincinnati that helped set up Denver for its run to Super Bowl 50, where the Broncos beat the Carolina Panthers 24-10 thanks to a defense that produced four takeaways and seven sacks.

Manning started all of Denver's playoff games after winning his starting job back with a comeback

against the Chargers in the regular season finale.

In comments at the league's annual scouting combine in Indianapolis on Wednesday, Kubiak echoed GM John Elway's stance that the Broncos will continue to give Manning all the time he needs to announce his plans.

It's widely expected, however, that Manning will forego the final season on his contract and retire a champion. He turns 40 next month and has been bothered by injuries each of the last two seasons.

"There is no hurry here," Kubiak said.

But there is a deadline. Manning's \$19 million salary for 2016 would become guaranteed March 9, and the Broncos cannot afford to pay two quarterbacks starter's money. Manning would face the possibility of being cut by the Broncos if he decides against retiring.

After Wilson's success, Adams gets a good look from NFL

NFL teams are intrigued by the comparisons between Vernon Adams Jr. and Russell Wilson as the former Oregon quarterback prepares for the NFL Combine.

Adams has said he patterned his game after the Seattle Seahawks star, and pro scouts saw the similarities during his senior season with the Ducks.

"He could draw some comparisons to Russell Wilson," ESPN's NFL draft analyst Mel Kiper Jr. said during a conference call on Monday morning. "Russell Wilson is 5-11 and Adams is the same type of thing. He had a good all-star game. He's a fourth-round type of guy who helped himself all year."

The similarities between Adams and Wilson were made explicit after Adams transferred from Eastern Washington to Oregon under the same rule that allowed Wilson to transfer for his

senior season to Wisconsin from North Carolina State without having to sit out a year. Wilson was a third-round pick by the Seahawks in 2012 and Adams could be selected in a similar spot during the draft on April 28-30.

Kiper said that Adams could be a good fit for ex-Oregon coach Chip Kelly if he decides to take a quarterback in the middle rounds for the San Francisco 49ers.

"I have talked a lot over the last month about Adams because of the Russell Wilson comparison, which will help him," Kiper said. "The third round is a best-case scenario, maybe fourth or fifth. The all-star game helped him, and if you look at the Michigan State game, if he does not overthrow a receiver, they possibly beat Sparty."

"When he was healthy, they were a different team offensively."

The 5-foot-11, 201-pound Adams completed 64.8 percent of his passes for 10,438 yards and 110 touch-

downs in three seasons at Eastern Washington. He completed 64.9 percent of his passes for 2,643 yards and 26 touchdowns in his one year with the Ducks despite missing three games and parts of two others with injuries.

In the East-West Shrine Game last month, Adams completed 6-of-9 passes for 191 yards and three touchdowns before being taken out late in the second quarter.

Adams will conduct media interviews on Thursday and work out Saturday at the NFL Combine in Indianapolis. He is one of five Oregon players invited to the showcase for NFL teams that runs Wednesday through Monday.

Oregon defensive end DeForest Buckner has little to prove at the combine after being named Pac-12 defensive player of the year as a senior. The 6-foot-7, 300-pounder had 83 tackles including 10 1/2 sacks.

Kiper has Buckner projected to be taken No.

3 overall by the San Diego Chargers and said he is in the discussion to be his No. 1 overall prospect in the draft along with Florida State defensive back Jalen Ramsey and Mississippi offensive tackle Laremy Tunsil.

"Buckner will go high, no matter what," Kiper said. "He is a rare talent for his size and he fits the 3-4 ideally which is why I have him to San Diego. He's a guaranteed top five or six pick. He's way up there in the stratosphere."

Oregon wide receivers Bralon Addison and Byron Marshall are seen as mid-to late-round selections heading into the combine.

"I have a third-round grade for Addison. He has a lot of versatility and speed," Kiper said. "Marshall probably in the fifth or sixth round."

Oregon offensive tackle Tyler Johnstone was also invited to the combine. The 6-6, 295-pound Johnstone was a first-team all-Pac-12 selection as a senior after missing 2014 with a torn ACL.
