Umatilla County youths in first through fifth grades still have time to create a logo for the Fun at the Fair Day Camp.

In addition to county-wide recognition, the winner will receive two adult day passes, four children's day passes and a one-day carnival wristband for the 2016 Umatilla County Fair. They also will receive a camp T-shirt featuring the logo.

The logo, which must incorporate the fair theme of Traditions & Transitions, will be used for camp T-shirts and promotional materials for the day camp, which takes place during fair week.

The artwork must include the words "Umatilla County Fair" in the design. The fair theme and the year will be added digitally to the winning artwork if not included by the original artist.

Drawn or sketched logo entries need to be in color on white paper or cardstock. Artwork must be submitted on paper no smaller than 8.5" by 11" and not to exceed 11" by 17".

The back of each entry must include the creator's full name, date, grade, teacher's name and school name.

The deadline for logo contest submissions is Friday, March 11. They can be dropped off at the fair office, 515 W. Orchard Ave., Hermiston, mailed to Umatilla County Fair, P.O. Box 94, Hermiston OR 97838, or e-mailed to angie.mcnaulley@umatillacounty.net.
