The Invasive Plant Management and Forest Plan Amendment to add aminopyralid to the list of herbicide ingredients on the Umatilla National Forest Draft Decision Memo (DM) is available for public review. The amendment would simply add this herbicide to the list of available herbicides for use on the Forest.
