

City of Pendleton has been granted a Categorical Exclusion from further environmental review for portions of an infrastructure project to be funded by the Drinking Water State Revolving Fund (DWSRF). The project consists of water distribution work in public right-of-way in Westgate/Hwy 30 and Northgate/Hwy 37. Oregon Health Authority Drinking Water Services concurred that the project is eligible for a Categorical Exclusion from further environmental review under Oregon Administrative Rule 333-061-0063(2)(a). Publication of this notice concludes the DWSRF environmental review process. February 25, 2017

About Public Notices

Public notices inform citizens about the activities of government bodies — such as budgets and public hearings, upcoming meetings and elections — so that citizens can make their opinions known before an action is taken or a rule or law is made. They also include information about foreclosures, unclaimed and forfeited property, estate claims and probate notices, summons, and calls for bids.

The four characteristics of public notices:

- They must be published by an independent and neutral third party,
- They must be archived,
- They must be accessible to the public,
- The public must be able to verify that the notice was not altered once published.

Newspapers provide an independent and archived record of public notices, accessible in print and online, and provide affidavits of publication when requested.

Public notices in newspapers protect the right of due process as guaranteed to Americans by the Constitution.

Sale of Impounded Livestock Umatilla Indian Reservation Reference: 25 C.F.R. 166807 (25 U.S.C. 179 & 3701)

Notice is hereby given that one (1) unauthorized horse was found on Indian trust lands. Tract Number C69 or the NW 1/4 of the SW 1/4 of Section 4, TWN 1 N, RNG 33 E, Willamette Meridian, on the Umatilla Indian Reservation. The horse was impounded by the Bureau of Indian Affairs at the Umatilla Agency, 46807 B Street, Pendleton, Oregon on February 23, 2017.

The horse will be offered for public sale to the highest bidder on March 3, 2017 at Fowler Road Trespass corrals at 9:00 am for Tribal Members only and 10:00 am for the general public. This sale is being conducted under the authority of 25 CFR 166.809 and 166.811.

The owners may redeem the horse before the time set for the sale following procedures listed in 25 CFR 166.810. Before the owner will be permitted to redeem and regain possession of the horses claimed by him/her, he/she must show proof of ownership and pay to the Bureau of Indian Affairs: (1) reasonable value of forage consumed, (2) penalty of double the value of the forage consumed, (3) damages to Indian trust property injured or destroyed and (4) all expenses incurred in investigating the trespass and the impounding, feeding, and care of the livestock.

Any of the livestock not sold at public sale may be offered for sale, condemned or otherwise disposed of as provided by regulation 25 C.F.R. 166.811. The successful bidder will be given a bill of sale to transfer ownership of the livestock.
