Sheriff's office nets five DUII arrests over **Memorial Day weekend**

The Umatilla County Sheriff's Office reported worked extra deputies patrols during the Memorial Day Weekend and made five arrests for driving under the influence of intoxicants.

Deputies also cited and warned 29 more drivers for traffic violations. Sheriff's Sgt. Joshua Roberts in a written statement called the effort "a great success."

The following breakdown of DUII arrests is from the sheriff's office:

•Roberts on Friday at about 8:15 p.m. stopped Alfredo Garcia-Preciado, 25, of Hermiston, for speeding on Powerline Road outside Hermiston. Garcia-Preciado's blood-alcohol level was .12 percent,

The chief stated that a Milton-Freewater police detective on Tuesday received a request from Walla Walla police to help find McIntosh at a residence on Tum a Lum Road near Birch Creek Road east of Milton-Freewater. McIntosh was driving a newer silver Nissan Altima, according to the report.
