Get your tickets

Fans looking to attend this year's Farm-City Pro Rodeo have plenty of options to choose from.

General admission costs \$17 per rodeo, with handicapped and companion seats at the same price. Tickets can be purchased online at Ticketmaster.com. Farm-City is also offering a military discount at \$10 per ticket.

Family night is Wednesday, August 8, which means children 12 years of age and younger are admitted for just \$5.

Reserved seating costs \$20, with only a limited amount remaining for the performances on Friday, August 10, and Saturday, August 11.

For die-hard rodeo fans or those looking to host a party, Farm-City is offering box seating packages. One box seat will cost \$25 per day, but packages are available to purchase entire boxes for the entire week. Sign-ups for a waiting list are available at the Farm-City office, located at 495 E. Main St. in Hermiston.

A huge turnout is expected this year, with the rodeo grounds accommodating 5,000 spectators. Rodeo-goers can find the main parking lot at the east entrance to the grounds for a \$5 fee, with additional parking available at any other Umatilla County Fair lot.

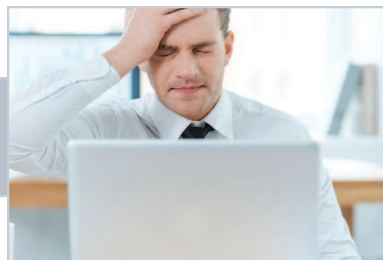
