head into my final season." Quinn, who helped lead the Mountaineers to a 3-1 overall record during the altered spring season, was one of a host of all-conference honors EOU received.

Head coach Tim Camp was named co-Coach of the Year for the Frontier Conference, while defensive lineman Chase Van Wyck was named Defensive Player of the Year, and John Lesser was named the Champion of Character for the Mountaineers.

In 13 seasons of leading the Mountaineers, Camp has a career record of 74-61 following the 2020 season. He led the Mountaineers to the program's first Frontier Conference regular-season

With 12 players earning All-Frontier Conference honors this season, Camp now has produced 89 all-conference players while leading EOU. He has had three defensive player of the year winners and two offensive player of the year winners.

With a 3-1 record, the Mountaineers looked good for an NAIA playoff spot, but lost out via the conference tiebreakers.

'We felt like we were a team that deserved to move on," Quinn said. "We will use that for motivation heading into the fall."

Joining Quinn on the first-team offense was Tanner Zenke, PJ Schubert, a Pendleton graduate, and Luke Thomas. Earning second-team honors was Lesser, Isaiah Thomas and Heppner graduate Patrick

Schubert and Collins, along with Thomas, were key on the Mountaineers' offensive line, leading a unit that helped pave the way for a ground game that averaged 194.5 yards per game. They helped the offense average 209.5 yards through the air and surrendered just eight sacks on the

"Offensively, we were much better in the run game and pass game due to the guys who we have around us," Quinn said. "On the offensive line, we had five big guys who did their job and made it easy for us. The guys in the trenches don't get the love they need. They deserve a lot more."

Earning first-team honors on defense were Van Wyck, Zak Donato and Solo Taylor. Dakota Hibbs was the lone selection for EOU on the second team.

Zachary Cahill was a first-team selection at kicker and was a secondteam selection at punter. Luke Thomas was a firstteam selection for special teams at both kick returner and punt returner.

FBS in total yards per game (412.9), including 166.7 rushing yards per game (61st). Iowa State outgained the Ducks 228-86 on the ground during the Fiesta Bowl.

"My coaching of the run blocking last year left a lot to be desired." offensive line coach Alex Mirabal said. "Those are things that we're jumping into and we're delving into right now in spring ball."

On the first play of the team portion of the Saturday, April 17, scrimmage at Autzen Stadium, C.J. Verdell, who missed the Pac-12 championship game and Fiesta Bowl with a thumb injury, ran for a 67-yard touchdown.

After hursting through the line of scrimmage, Verdell only had to make a safety miss on his way to the end zone.

'It kind of lets you know that every drill that we work, every assignment that we do, hat placement, hands, all that comes into play when you see C.J. takes off and scores that run," Moore said. "It was kind of a relief knowing that everything we're doing, once we go out there and actually play a team, it's going to be put in full effect."

Third-year sophomore Steven Jones (right tackle) and junior T.J. Bass (guard) are the other returning starters on the offensive line. Malaesala Aumavae-Laulu, who played right guard and right tackle last season, has been limited this spring due to injury.
