Spratling awarded Lindberg scholarship

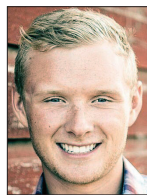
PENDLETON — Tyler Spratling has been named the recipient of the 2021 David Jon Lindberg Memorial Scholarship.

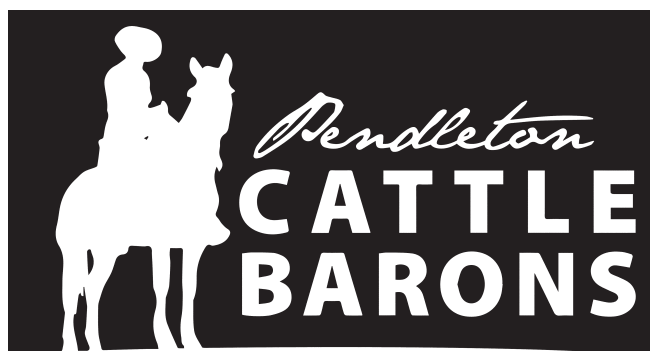
