They settled in Weiser, Idaho, and soon purchased a four-room house across the river in Oregon. It quickly proved to be too small for the expanding family but, undeterred, he began to add onto the structure. He later bought some used farm trucks to do custom hauling for farmers and found some success with that.

In 1974, he found an opportunity for work in

the Hermiston area and the family made the move to, as he called it, "Marlboro Country!" He held a variety of jobs ranging from construction laborer to potato plant warehouse worker. For many years, he worked on the railroad. He followed up on that by starting a successful delivery business for tortillas and Mexican pastries. His generous nature and kind heart contributed to his prosperity and was appreciated by both his family and customers.

The family loved to go camping in their pick-up-mounted camper, although the boys had to sleep under the truck at night. Early mornings would see Aurelio out with his fishing pole trying to catch breakfast while the kids were splashing in the water around him with an early morning swim. Eventually, he would give up and have to return to the camper, where he invariably would crank up the Spanish music loud enough for everyone at the lake to enjoy.

This coming September, he was looking forward to celebrating his 70th wedding anniversary. His love of life was contagious and infected the entire family.

Rev. Lawrence Cooley Ferguson Jr.

Prineville

The Rev. Lawrence Cooley Ferguson Jr. passed into God's glory June 27, 2021, in Prineville, Oregon. His beloved wife Anna, predeceased him in 2016. He is survived by his three adult children: Elizabeth Sarah Ferguson, Lawrence Cooley Ferguson III (wife Kim, daughters Elise and Emily Ferguson and granddaughter Kaileena Ferguson) and Ruth Ann Walker (husband Patrick Walker and their sons Ross and Todd Walker).

"Larry" was born Nov. 20, 1934, in Pittsfield, Massachusetts, and after graduating from Lenox School Episcopal Boarding School in Lenox, Massachusetts, pursued an M.Div at Episcopal Theological School in

Cambridge, Massachusetts. He and Anna were married on June 20, 1959.

In 1959 they moved to Oregon, where Larry served as rector of St. Mark's Episcopal Church in Madras and St. Albans Episcopal Church in Redmond. He served both churches simultaneously for the first two years.

In 1968, the family moved to Hood River, Oregon, where Larry served as rector of St. Mark the Evangelist Episcopal Church until 1986, when he and Anna moved to Prineville, Oregon. Larry served as rector of St.

Andrews Episcopal Church of Prineville from 1986 until his retirement.

A beloved priest, counselor and mentor, Larry was known for his deep belly laughs and down-to-earth pastoral presence. His concern for people struggling with mental health issues led to his long-time involvement with Mid-Columbia Mental Health, Central Oregon Mental Health and State of Oregon Mental Health.

On more than a few occasions, his deep faith was expressed in blunt assessments, often with the introductory line "Well that's a

load of crap," followed by a wise chuckle. Never shy of sharing an opinion, his stance on most any topic was rarely on impulse — for Larry, debating a point of theology or ecclesiology was not about winning but about teaching. He was well known in the Hood River community for his welcoming personality and openness to anyone who sought pastoral advice, or wanted to swap fishing stories.

The memorial service will be on Sept. 11, 2021, at 1 p.m. at St. Mark the Evangelist Episcopal Church in Hood River.
