PENDLETON — The Oregon East Symphony recently received a \$10,000 grant award from the Braemar Charitable Trust to support the symphony's Playing for Keeps project for students in fourth through 12th grades. The grant will support classical music education in the Pendleton area with after school classes for the following: fourth and fifth grade beginning strings students; a beginning strings ensemble for students; an intermediate orchestra for all ages; a mentoring program for advanced high school musicians; a weeklong strings instruction day camp; an instrument loan program; financial support for private lessons/program entry fees; and a Young People's Concert, which is held twice a year.

PENDLETON — The Umatilla County Historical Society has received \$15,000 for maintaining and upgrading the Heritage Station Museum in Pendleton.

The grant funding comes from Union Pacific Railroad, the historical society announced in a press release. The funding will be used to replace the museum's doors and redesign the admissions area. It is part of the historical society's capital improvement project.

I-84 Frontage Road: Meacham Creek and UPRR Bridge Closure

The Oregon Department of Transportation is closing the Meacham Frontage Road Bridge for geological drilling operations. **Closure begins October 13.** **Closure ends October 15.**

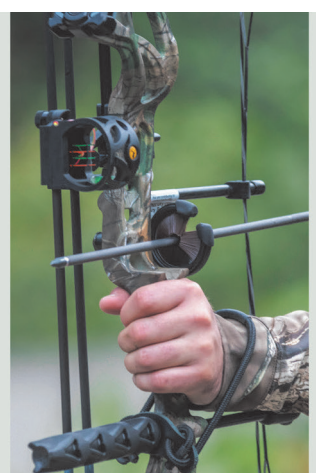
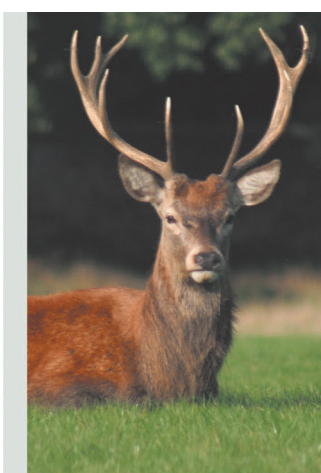
TRAVEL IMPACTS: Frontage Road will be closed at the bridge. Detour signs will guide travelers around the closed section.

PURPOSE AND NEED: This reinforced concrete deck girder bridge was built in 1925. Extensive deterioration, increasing maintenance costs and potential safety concerns require a complete bridge replacement. ODOT is scheduled to begin construction in the spring of 2023. Engineers will use soil samples taken during drilling operations to determine appropriate materials, size and depth of new bridge footings.
