**Pilot Rock fire tax only item on November ballot**

PILOT ROCK — With federal, state, municipal, school board and most special taxing districts holding contests on a different part of the election calendar, Umatilla County will hold only one election Tuesday, Nov. 2.

The Pilot Rock Rural Fire Protection District is asking its voters to approve a local option tax of 82 cents per

\$1,000 of assessed value to maintain the district's level of service. According to the election notice, the district will use the tax revenue to pay for the quick response team, personal protective equipment for staff and vehicle repair and replacement.

Voters who haven't sent in their returned ballots can submit their votes at the drop box in front of Pilot Rock City Hall, 144 N. Alder Place. Voting closes at Nov. 2 at 8 p.m.
