The CITY OF PENDLETON is seeking a qualified contractor to construct the **Runway 29 Threshold Relocation, New Taxilanes and Apron Rehabilitation** project. Major elements of work for the project include Relocation of the Runway 29 Threshold, construction of two new Runway 29 connector Taxiways, associated Medium Intensity Runway Lighting (MIRL) and Runway 29 and taxiway signage improvements, Runway 29 Precision Approach Path Indicator (PAPI) relocation and replacement, Runway 29 REIL relocation and replacement, and associated electrical improvements, excavation and site grading of runway and taxiway shoulder and safety areas, and associated drainage improvements.
