

The City of Irrigon Planning Commission will hold the following hearing at 6:00 p.m., June 4, 2022, at City Hall located at 500 NE Main Avenue, Irrigon, Oregon. Information to join by Zoom will be available on the City's website.

Subdivisions: Property is described as Tax Lot 201 and 202 of Assessor's Map 5N26E24CD and is zoned Residential. Request is to create six lots for residential purposes. The procedure is a Type III under the Irrigon Development Code 10-4A. Criteria for approval are found at 10-4C and Chapter 3 Community Design Standards.
