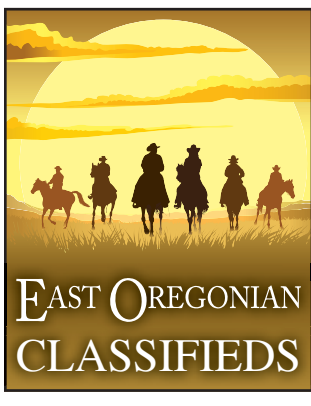

The City of Umatilla is eligible to apply for a 2022 Community Development Block Grant from the Business Oregon. Community Development Block Grant funds come from the U.S. Department of Housing and Urban Development. The grants can be used for public facilities and housing improvements, primarily for persons with low and moderate incomes. Approximately \$12 million will be awarded to Oregon non-metropolitan cities and counties in 2022. The maximum grant that a city or county can receive is \$2,500,000. The City of Umatilla is preparing two applications for a 2022 Community Development Block Grant from the Business Oregon for #1. Construction of water utility extension to the Power City area and Brownell area behind the ODOT weigh station; and #2.
