BLACK LIST. ON THE 3d day of July, 1865, MESSRS. FERGUSON & CO. paid me an account in GREENBACKS, AT PAR, for a blacksmith bill, done at coin rates, Coeville, July 25, 1865.

The above notice was a misunderstanding between Messrs. D. H. Ferguson & Co. and myself. They were simply securities for an attachment for the amount of \$45, which was paid by the parties who contracted the debt.
