OUR RESERVED RESOURCES.

Strangers passing through our city often ask "Will your hillsides ever be cultivated?" In settling the question thus started, one fact is worth a thousand arguments. Let us accept the facts for answer. Agriculture on our hills has been tried to a small extent, and not yet pronounced a success. A field ditched in, on the sidehill near Five Mile Creek, and sown with oats, did not pay. On the other hand, we find farmers on the creeks slowly extending their tillage to sidehill benches above the alluvial soil, and in some instances, with manifest profit.

There is a family now making a home about two miles south of our town, in a depression among the hills, which has no surface water in summer; but in which a well of ordinary depth yields water, as wells ordinarily do. The garden was good last summer without irrigation; yielded an abundance of good melons and other garden produce, among which was quite noticeable, a good crop of potatoes. An orchard, too, has been commenced, and this fall the experiment still farther extended in a trial with winter wheat. Mr. Brooks, who is the man making this experiment, thinks it already a success, as it stands.

Let us now suppose a good woolen factory at this place of ours we call the Dalles. Manifestly Mr. Brooks would at once want 100 sheep, and would be at no loss to know how to take care of them. Hundreds of others would find pleasant spots among our hills now deemed untenable. The really productive thing of all these hills is the grass: the tillage need be no more than sufficed to raise an orchard, a garden, enough grain in the sheaf to guard a flock of sheep from a possible severe winter, and a competence becomes a foregone conclusion. The wool market may yet answer for Wasco County the oft-repeated inquiry, "What are your hillsides good for?"
