

LETTER FROM BAKER CITY.

BAKER CITY, Nov. 23d, 1865.

EDITOR MOUNTAINEER:—Our little town, which has been established since the erection of Col. Ruckle's quartz mill, is growing rapidly. We have a number of stores, a hotel, butcher shop post and express offices, and many new dwelling houses are being built.

Col. Ruckle has been here for the past ten days, giving his personal attention to the working of his mill and lode, which are now working splendidly, and the ore coming from the depth of 130 feet is very rich.

The farmers are now preparing their ground with the anticipation of raising heavy crops next season.

THE PORTLAND AND SACRAMENTO MAIL.—The Oregonian announces that Col. Markland, the Special Postal Agent, intends to report in favor of the reduction of the service between Portland and Sacramento to a weekly mail, after June next.

LAKE SUPERIOR AND PUGET SOUND RAILROAD.—A late dispatch from Montreal, Canada, says: "Col. Rowland as Commissioner of the Northern Pacific Railroad Company, is here conferring with the Canadian Government and others, relative to uniting British capital with the grants of the United States in the construction of a Lake Superior and Puget Sound Railroad."
