The discovery was made Saturday, 11th inst., and contains a ledge of about eight inches in thick. ness. A claim of eight hundred feet was located by the above named parties. The quartz shows free gold in considerable quantities, and also sulphurets of silver.

ABRIVED. The remains of George Garber, the Orderly Sergeant of Co. "G," First Oregon Cavalry, arrived at Fort Dalles yesterday evening. Sergeant Garber was one time a citizen of this place, and bore a high reputation as a man of spirit and good feeling. He entered the service from the highest motives of patriotism, and won the reputation of being a thorough soldier. He had recommended himself to all with whom he was connected in the service, and only needed a wider field to have become conspicuous. In the battle in which he was mortally wounded he fought for some time after he was hurt. He was brought back to Camp Watson, where he died on the 18th inst., the day following the fight. His thoughts were evidently about his duty to the last moment, as his last words were to order the bugle to sound to change the guards. He will be taken to Vancouver for burial.


