Ruckles Quartz Lodes and Mill The lodes formerly knowe as Rock fellow's quartz discovery, on the waters of Powder River, have lately been worked with renewed energy by Col J. S. Racklo, the present owner of the mines, with very flattering results In a run of thirty-six consecutive day in November and December, the extraordinary yield of $\$ 36,500$, in round numbers was realized - the quartz running from $\$ 45$ to 885 a ton
On account of the mill being driven by water-power, crushing is suspended until spring breaks, when ten stamps will be added to the ten already in operation. The mill is located on Powder River, about soven milea from the lodes where the quartz is obtained; and is a very complete establishment, in perfect running order.

The original discovery of Rockfel. low and party and includes five loder, viz: the Union, Rocky, Eareka, Ophir and Hoosier; Of these, the Union is best developed, and the location of the ground is such that it is first reached by the same adits intended to work all the lodes. A shaft has been sank one bundred and forty feet on the Union, and an adit has been run in something over a hundred feet to the bottom of the shaft. Another is foar handred feet in, which will strike the Union two hundred and fifty feet from the surface. The mines are expecting daily to strike the Union in this adit. Galleries have been run sixty or seventy feet eaeh way from the deep shaft, and work is still progressing upon them. The average width of the Union is about three feet with a dip to the nortb. The rock is remarkably clear of all combinations oveulated to impedo amalgamation, and in general improves as it is sunk upon. The other lodes are of about the same average proportions, running parallel to this at short distanees from it, and will be all worked from the same adits.
The gold from these lodes averages about 81940 an ounce, and contrary to the general belief in regard to quartz carrying gold of great fineness, it is evenly distributed, and promises to run with as much regularity as in any silver lode discovered in the Co lumbia Basin. It is, however, me occasionally in very considerable quan tities af the aame purity as that taken from the batteries.
Important Decibion in Relation co the Locatton of Roads - We learn that, in a case reserved from Umatilla County, Judge Wilson bas deeided some questions, whieh may be of great moment to the public:

1. In the viewing and locating of roads, it is necessary, that the wholo number of viewers, appointed by the County Court, should be present at such view and location. A majority of the viewers may make and sign the report of their proceedings, but all mast join in the aets of lecation.
2. A plaintiff, having sued for dam. ages for tresspass, recovered a judga ment for twenty'five dollars, held, that defendant must recover costs and all proper disbursmente from the plaintiff.
Doubtless, many of our roads are liable to this defect in their estatlish. ment; and our County Courta cannot be tod eareful in that branch of their business.
