A Young man named Dimmick, living in Benton county, was last week lost for three days in the Coast Mountains. He walked constantly the whole time, and finally arrived at the house of a settler, in a state of great exhaustion.

GRANT COUNTY DELEGATION .- The following gentlemen compose the Union delegation from Grant county to the State Convention : M. A. Berry, F. Adams, H C. Gregory, T. R. Brendt and J. F. Wolfinger. The county convention meets on the 1st of May for the nomination of county officers.

CANYON CITY.-Sheriff Berry, who arrived from Canyon City yesterday informs us that high water in the Canyon had done considerable damage to the miners by filling up their claims; but that they had now got fairly to work, and the prospects were that they would reap a rich harvest the present season. Indian depredations still continue on the road between here and Canyon. Only a few days since, the Indians drove a band of horses they had stolen, so close to Camp Watson that the sentinel could distinctly recognize them. In fact, the savages are becoming so bold that they do not seem to pay any attention to the presence of the troops. Every person who owns a cow or a horse about Canyon City is compelled to guard them; and miners are confined to the limits of the town, in order that they may not loose their hair, thus effectually retarding the development of the richest mineral region east of the Cascade mountains. How long is this to last? How long before our military authorities wake up and see the necessity of sending more troops to protect the lives and property of these people who are the bone and sinew of the government? This military department was once cursed by the presence of an old granny who commanded it for three years, and but for whom, there is not the least doubt, those red devils would have been long since exterminated. Let the citizens of the Dalles and Canyon City follow the example of those of Boise and Ruby cities, and we will vouch for the result.

FROM CANYON CITY-SAD NEWS .-We have received from Mr. James A. Henderson, Agent of Wells, Fargo & Co., Canyon City, the following noteaddressed to him, conveying the sad intelligence of the death of Mr. Benj. Powers:

Middle Fork Road, 16 Miles From Canton Citt.

Mountain House, March 12, 1866.

MR. HENDERSON-Agent Wells, Fargo & Co., Canyon City:- I have sad news to communicate. Benjamin Powers is dead-he froze to death last night. We had got within five miles of the Mountain House when Ben. gave out. One other of the party threw away his biankets. When Ben, and myself came up he (Ben.) concluded to stop and build a fire, and

stay there all night and come on in the morning He had plenty of matches with him, so I did not feel uneasy about him. The balance of us came on, and when within a mile of the house, John Johns, the blacksmith, gave out. As I could render him no assistance, I came on to the house. We made the facts known, and one of the men belonging to the house went back and brought him in about 10 o'clock, with his feet badly frozen. As for Ben., we felt no uneasiness about him. We left him with two pairs of blankets and plenty of matches. As be did not come in that night, we despatched a man early this morning with food to him. When he found him he was two miles this side of where we left him, just alive. The man found he could do nothing by himself, so he built a fire and came back to the house, when all hands went out, but Ben. was dead. F. McBEAN.

Mr. Powers will be remembered as the man who assisted in raising Capt. Boland's company of volunteers, in this city, about eighteen months since, and who refused to be commissioned owing to some misunderstanding between himself and Gov. Gibbs. At the time of his death he was on his way to attend the Union State Convention, as one of the delegates from Grant county. Mr. Powers was a gentleman of more than ordinary in telligence and of fine social qualities.

YAQUINA BAY .- The Corvallis Ga. zette publishes a long letter from the Yaquina Bay country, which has recently been cut off from the coast reservation and thrown open for settlement. A town site has been laid out at the head of the bay, forty-two miles from Corvallis, over which distance a company with a carital of \$20,000 is making a wagon road. It is claimed for the Bay that there is good and safe entrance there for vessels draw. ing not over 18 or 20 feet, and that it is so situated that it must become an important shipping point. The writer

Here, then, the problem is solved. This Bay and Harbor is a realitynavigable for large ocean steamers for 25 miles. The harbor is safe, and 1,000 vessels can be anchored in it in perfect safety. Its entrance from the ocean is superior to any inlet from San Francisco to Puget Sound. The route from Corvallis to the bay is perfectly adapted to a railroad; of this there can be no question. Here, then is a matter of vast National, as well as local importance, one which has been overlooked heretofore-the bay, harbor and, and whole country on this slope having been included in two Indian Reservations. In fact, it has been generally supposed that the coast westerly was an iron bound concern.

In addition to the above there is quite an extensive oyster fishery in the bay, which already gives employment to some twenty five persons. The oysters are loaded in schooners and sent to various points on the coast, besides many are packed for the interior trade.
