\$SALEM, Or., Oct. 16.-(Special.) -The Desert Land Board today held in abeyance the petition of 99 settlers on the Central Oregon project asking to be allowed to reclaim 9000 acres of land outside of the project and altogether open 12,000 acres of land. The cost was to have been approximately \$115,000. Jesse Stearns, Engineer C. M. Redfield, J. F. Rice, * Powell Butte, and Attorney L. M. Bechtel, of Prineville, appeared before the board in behalf of the settlers. The board will not act on the petition until after the county court takes up the matter of irrigation district petitions already circulated.


