STANFIELD.

The announcement of the Stanfield candidacy for the Senate is not a surprise. For some time it has been rumored that the sheepman would try again. Confirmation of the rumor will be received with gladness by all those who shared in the distribution of the thousands of dollars spent in his behalf in the last campaign. Once more they will see money in great wads coming their way and with this prospect they can be depended upon to fawn upon him, praise him to the skies and assure the public that he will be elected.

Whether or not Mr. Stanfield can be elected, can even get the Republican nomination for the senate, we have no idea. The record for money spending on behalf of the nomination in the last campaign is against him because the people of this state have a distinct prejudice against getting political office in that way. FANS SEE FAST FISTIC BOUT

at Fred's mercy as the round ended.

The sixth again was Fred's—until the last minute. Willis, who had been backed up against the ropes, with both arms along the top strand, swung heavily with the right as Gilbert approached, adding the force of the blow by pulling himself forward with his left hand still grasping the rope. Gilbert fell like a log, and his backers made ready to pay their bets. Without taking time for his full rest, Gilbert rose dizzily at the count of five, Willis allowing him ample opportunity to regain his feet. Gilbert stalled for the remaining 30 seconds of the round, swaying dizzily, but keeping so well under cover that his opponent was unable to end the bout.

Fred was still not himself in the seventh, and played safe, gradually strengthening as the round progressed. In the eighth he was back on the job again and assumed the offensive, but his blows lacked their former steam, and a majority of his punches were blocked. Both men were tired but in spite of the drubbing he had taken in the sixth, Fred was stronger, and it was Willis who repeatedly sought the haven of a clinch.

Preliminaries Interest.

In the last two rounds both men fought furiously to land a knockout punch, but it is doubtful at this stage of the game, if either had sufficient strength left to put over a 10 count blow. Gilbert's chin connected a number of times with Willis' left, and in his turn the Bend fighter made incessant attempts to plant his right to the jaw.

One of the most accomplished boxers and two handed hitters seen in the ring here for many moons, is Frankie Warren, who battled Milton Newman in the main preliminary. In the first round, feeling out tactics were mutually used, but in the second, the gong saved Newman from a knockout at the count of five. In the third, Newman was weak, and quickly succumbed to a shower of rights and lefts to the head. Three times he raised himself from the

mat, sub-consciously attempting to fight, and each time a tap from Warren sent him back to the canvas. The gong sounded at the count of eight, but a continuance of the fight was a physical impossibility, and Newman was carried from the ring.

The Swigert-Golden go was fast and furious while it lasted, with Swigert rushing it with hard fast swings, which during the first two rounds caused Golden to give ground continually. In the third, the retreat ended, and in the fourth Golden slipped a hard one to Swigert's head, making the favorite groggy, and resulting in a knockout before the end of the round.

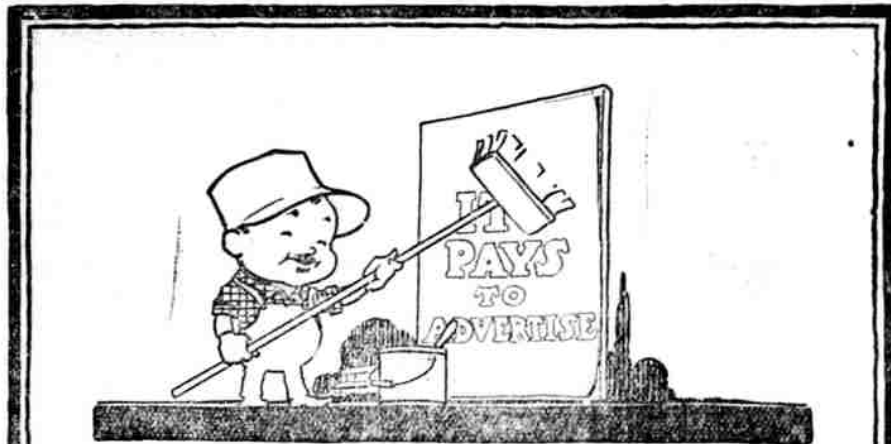
