VALUE OF TIMBER TO BE APPRAISED

Bruce Hoffman, Logging Engineer For Forest Service, Declares Sisters-Metolius Belt Presents Big Chance For Operation.

That the government owned and privately held yellow pine timber in the Sisters-Metolius country constitutes the best opportunity for pine operators left in the northwest, is the declaration of Bruce Hoffman, logging engineer for the district office of the U. S. forest service, who was here today from Portland, conferring with Supervisor H. L. Plumb of the Deschutes national forest.

FLOODS SWEEP ACROSS JAPAN

ENTIRE VILLAGES SUBMERGED—DEATH LISTS NEAR 200—THOUSANDS BARELY ESCAPE AS DISTRICTS ARE INUNDATED

Entire villages are submerged in 15 feet of water in the Hita district and 600 houses are washed away at Kyushu.

POLICE FIGHT WITH SAILORS

ONE KILLED, 7 JAILED AT LINNTON

Crew of Tanker Declared Menaced, Officers Take Hand, Battle Spreads Over Docks And Surrounding Country.

(By United Press to The Bend Bulletin.) PORTLAND, June 21.—One is dead and seven are jailed as the result of a gun battle between alleged strikebreaking seamen and policemen at Linnton last night. John Darrel was killed.

A bus driver hauled eight men to the Shell Oil docks near Linnton, then reported to the police that they were planning mischief against the crew of the tanker, City of Reno. The police investigated, were halted and a battle ensued over the docks and surrounding country.

MANAGERS FOR CLUB BUILDING WILL BE NAMED

EXECUTIVE BOARD OF LEGION TO MEET

CHANGE IS APPROVED

People Generally Favor Action of Ex-Service Men In Accepting Gymnasium Management—Jubilee Follows Making of Decision.

The board of managers for the gymnasium, which will hereafter be known as the American Legion building, will be selected tonight at a meeting of the executive board of Percy A. Stevens post No. 4, called for 7:30 o'clock in the gymnasium, Commander Frank R. Prince announces.

The immediate action on this matter is called for by the need for a janitor in the building and the desire to start the process of renovation, so that the building will be ready for an opening before the Fourth of July.

Action Wins Approval. Sentiment expressed about town this morning was all in commendation of the Legion's action in taking over the management of the building. That Percy A. Stevens post is the one organization which should be able to run the building successfully and make it a real community center was stated on all sides.

By a vote of 58 to 1, Percy A. Stevens post No. 4, American Legion, last night voted to take over the management of the Athletic Club building, offered to the post by the Bend Holding Co. Plans for operation and the date of opening were left to the executive committee.

In accepting the task of operating the building, the Legion post is acknowledging that it owes the community a service, it was stated last night by Commander Frank R. Prince. While the public may still owe the individual ex-service man something, the Legion is in existence to be of continued service to the people in general, he said.

Expenses Summed Up. In summing up the expenses which will be incurred in keeping the building open, C. H. Knowles estimated that \$8820 would run the building a year. This includes salaries for a manager, bookkeeper and janitor, light, water, fuel and overhead expense.

The income was estimated as follows: Six thousand dollars from memberships, \$1000 from the schools, \$2000 from rentals, and \$6000 from activities staged by the Legion post. This included athletics, dances and theatricals.

In spite of this seeming opportunity for a profit, it was stated that probably no more than a fund for repairs would be left at the end of the year.

Loss will be guarded against, it was declared, by using a budget system and a departmental division by which a checking up of the finances of each department will be made at the end of each month, and if a loss is shown, proper steps taken.

Parade Follows Meeting. A lively indoor baseball game was played previous to the meeting and singing followed it. Later the members of the post serpentine downtown, entering a number of business houses.

The parade was broken up when someone, who later declared that he did not know what was going on, drove a car through the line. Twenty ex-service men caught the rear end of the car, forcing it to halt after running a block. The driver was warned not to break through a parade again.

POWELL BUTTE WILL DANCE ON JUNE 24

The June ball given by the Powell Butte Community association will be given Friday evening, June 24, at Powell Butte hall, it is announced. Redifer's four-piece jazz orchestra will furnish the music. Proceeds from the dance will go to the public fund of the association. Dancing will begin at 9 o'clock and later in the evening supper will be served.

PROBLEMS FACE NEW BOARD AT EARLY MEETING

MUST PICK FROM TWO SUPERINTENDENTS

POSITION IS CROWDED

Action of Old Board In Declaring Moore's Contract Void Deemed Hasty—E. P. Mahaffey and Mrs. Richards To Be Sworn In.

The novel situation of a city with two school superintendents presents problems which will be among the first which the new school board will have to solve, is the belief of E. P. Mahaffey, who, with Mrs. Horace Richards, was yesterday elected to membership on the directorate of the Bend school district. Mr. Mahaffey questions the right of the board previously in office to declare the contract with S. W. Moore void.

As this action was followed by the signing of Mark A. Paulson as superintendent, the position is left badly crowded, and one of the incumbents will have to go, Mr. Mahaffey pointed out.

Mrs. Richards said that from the information which she now has at her disposal she considered that the old board had possibly been somewhat hasty in voting to dismiss Mr. Moore. She believed the question one which would merit further investigation.

1919 Election Recalled. When the matter was brought up before the old board, four members, H. E. Nordsee, Mrs. E. M. Thompson, L. M. Foss and George Gove, favored the dismissal of Mr. Moore. C. A. Hayden opposed this stand.

As the result of yesterday's election, Mr. Nordsee and Mrs. Thompson are no longer members of the board. Six hundred and twenty-two votes, the largest number ever polled in a Bend school election, were cast in the selection of directors. The previous high record was in 1919, when an unsuccessful attempt was made to recall Carl A. Johnson. The number in the 1919 election was 473.

Results Officially Declared. Mr. Mahaffey polled the high vote in yesterday's balloting with 351. Mrs. Richards had 330 to her credit. Mrs. Thompson was third with 282, and Mr. Nordsee had 262 supporters.

Election officials said that the ballots would not have strongly indicated the existence of a ticket, pairings of various sorts were noted. Immediately after the completion of the vote, the board met and officially declared the election of Mr. Mahaffey and Mrs. Richards. The organization meeting at which the new members will be sworn in will probably be held tomorrow or Thursday evening.

JAPANESE HURT IN LABOR WAR

POLICE SLASHED AND WORKERS WOUNDED IN RIOT AT OSAKA FOLLOWING PRESENTATION OF UNION DEMANDS.

HONOLULU, June 21.—A number of police were knife-slashed and numbers of workers were wounded in a riot in Osaka, Japan, according to dispatches received by the Japanese paper Jiji. Osaka employes presented 10 demands, including collective bargaining and other usual labor demands. The employers refused and the riot started. Much unrest is reported among other workers in the city and further trouble is feared.

INDUSTRIAL COURT AGAIN CONDEMNED

(By United Press to The Bend Bulletin.) DENVER, June 21.—The American Federation of Labor again condemned the Kansas industrial court today, when the convention unanimously approved the report of the executive council condemning the industrial court plan.
