OILING THE HIGHWAYS

After all the fuss stirred up last spring over the oiling of the Columbia River highway it is now interesting to observe that there is a general demand for oiling the Mount Hood road. Opened to travel last Sunday, the loop road carried hundreds of cars through the day—and there was a cloud of dust over everything. Immediately a call for oil went up. The highway commission has heard to call and at its current meeting an order that a light coat of oil be applied.

Of course a car will become oil pattered if it is driven rapidly over road on which oil has been recently distributed. Equally, of course, the engineers of the highway commission did not go into this business of oiling without taking careful account of its fact and the fact that a few days later oil is put on there is no longer any spattering to be feared, the surface of the road becomes dustless and readily improved for travel. The advantages greatly outweigh the disadvantages, they decided, and proceeded with the job. The results have demonstrated that the critics were talking in ignorance.

The business is of particular interest here because we are dependent on incadum highways which tend to become very dusty and which therefore need treatment of some sort. It is difficult to realize, but it is a fact that within 12 months from this time here will be recently finished or under way a continuous stretch of over 6 miles of broken stone surfacing between here and Crescent. That whole section should be oiled. Oiling can be secured if the subject is properly approached, but criticism and division of opinion will effectually prevent the improvement.

Safety Is Promised Shameen Foreigners

By Alfred Hicks (United Press Staff Correspondent) HONGKONG, June 27.—The Canton government has given the most explicit assurances that it will prevent any further anti foreign demonstrations at Shameen, the foreign quarter of Canton. The situation is still tense, although there appears to be no ground for rumors that the Chinese intend to seize Shameen. Germans at Shameen have been guaranteed full protection by Chinese authorities, provided they wear white armlets. Americans from Canton, now here fleeing from Canton, issued a statement emphatically recording their disapproval of the attitude of American teachers of the Canton Christian college who had issued a statement blaming Shameen foreigners for the Tuesday shooting. The vice president of the college has retracted the statement but the Americans desired to make their ideas known. Refugees held the teachers had shown lack of judgment and restraint.

The above despatch would tend to indicate that reports of a new massing of Chinese for an attack on Shameen, as carried by an agency other than the United Press, were exaggerated. Roosevelt Highway's Completion In Sight (U. P. Leased Wire to The Bend Bulletin) PORTLAND, June 27.—Completion of the Roosevelt coast highway in Curry county was brought in sight when the state highway commission located the route of the highway between Pistol river and Brookings and ordered the entire distance of 23 miles advertised for grading contracts. Bids will be opened at the next meeting July 28. This will leave but one other section of the highway in Coos and Curry counties ungraded—the Euche creek-Gold Beach section.
