Doghouse, Harrington and Dieters did the scoring for the Tumalo nine. Dieters also won batting honors, getting three hits out of his four trips to the plate. Only one error was charged to the Bend team. Tumalo is charged with six. Russell struck out nine batters and Dieters struck out seven.

Russell Scott Sanity To be Left to Jurors

CHICAGO, July 27.—Russell Scott, twice spared from hanging by eleven-hour reprieves, will face a jury in Judge Joseph B. David's court one week from today, the jury to decide whether or not he is sane, Judge David decreed today.

"There must be no delays or continuances," Judge David warned William Scott Stewart, attorney for Scott.

A special venire of 100 jurors is to be called for service in the sanity hearing.

If the jury decides Scott has become insane since he was first sentenced to hang—as Stewart claims he has—he would be confined to the state hospital for the criminal insane and will be subject to hanging at a future date if he is later found to be sane.

RESTOCK PAULINA WITH TROUT, PLAN

Deputy Game Warden Arrests Five Violators

Restocking of Paulina lake with trout is under consideration by the state game commission, according to information obtained today from F. M. Brown, chief deputy state game warden, who is in Bend, returning from East lake.

Fishing in Paulina lake, once a mecca for anglers, has not been good in recent years. In connection with the proposed restocking of the Newbury crater lake, Brown mentioned that Pearl Lyles, superintendent of the Tumalo and Fall river fish hatcheries, is making preparations to place a half million Eastern Brook trout in East lake in the immediate future.

Five arrests were made by Brown when at East lake. He was accompanied by H. E. Meads, ranger warden. Three of the men arrested appeared in Judge E. D. Gilson's court this morning. L. A. Myers of Lakeview, charged with fishing after the sunset time limit, was fined \$25 and \$4.20 costs. W. E. Lord of Los Angeles, arrested on the same count, was given the same fine, as was C. D. Keller, also of Los Angeles.

Two Bend men, Glenn Fowler and L. W. Van Tassel, were also arrested by Brown, charged with fishing on the wrong side of the "dead line" of the closed area at East lake. They were booked to appear before Judge Gilson this afternoon.
