streets and could not tell which way the men went.

Although the absence in Monitor yesterday of the four young men who were taken prisoners by the convicts caused some speculation, the stories told by them and the Newman family were the first definite clues indicating the whereabouts of the convicts since the night of their escape last Wednesday.

Wilde, one of the hostages taken by the convicts at Monitor, had been in charge of the pool hall there. In front of the building is a cigar and confectionery store, and back of this, separated by a partition, are the pool and card tables.

Wilde, Lichte, Jacobs and Luelt were in the rear room playing cards about 2 o'clock Monday morning when Murray and Kelly appeared at the partition door. Wilde was facing the door.

"Murray was ahead, armed with a revolver," said Wilde, in recounting his experiences. "Kelly had a rifle. We found later that Willos, who had a rifle and revolver, had gone to the

No Shakeup Contemplated In Game Commission

Report Declared Attempt to Discredit Work of Department, Asserted by New Chief of Board

There will be no shakeup in the personnel of employees of the state game commission, regardless of rumors which have been current in many sections of Oregon in recent weeks. This is the information received locally from E. F. Averill, who recently succeeded A. E. Burghdoff as state game warden.

It is very apparent that an organized attempt is being made to discredit the work of the game department by circulating statements to the effect that the entire force of employees is to be reorganized on a political basis." Averill mentions in a letter received by employees of the commission in Central Oregon and in other parts of the state, "I have been instructed by the Oregon state game commission to advise you that all such statements are false.

"The commission at its meeting held August 19 authorized me to say to you that the force is not to be reorganized on a political or any other kind of basis, and that so long as each employee does his work faithfully and efficiently, refrains from every kind of political activity and does not violate any of the laws of the state or nation, his services will be continued.

"I realize you have been more or less disturbed by the reports that you were to lose your positions and that you have thereby been hampered in the performance of your duties. I certainly hope you will take the statements contained in this letter at their face value and from now on give your undivided attention to your work.

"For myself, I ask only the same loyal cooperation that you extended my predecessor, and I feel sure that as we become better acquainted, our relationship in the work will be mutually pleasant and satisfactory." Averill says in concluding his letter.

The game commission as now constituted is determined to carry on with renewed vigor the work of propagation and protection of game birds and fish in order that there may be more and better hunting throughout the state, the new state game warden remarks in his letter.

City Prisoner Is Drunk But Money Is Plentiful

One of the most affluent prisoners whom the Bend police have ever had in their custody was Joe Anderson, arrested Monday night on a charge of drunkenness. Anderson was in Bend for a "toot" from one of the Natron cutoff construction camps, and he had \$300 in his possession. He was released this morning on \$10 bail and did not appear for hearing in the municipal court.
