HERALD TO WINTER**

Freezing Point Touched On-ly Twice, However

Heralding the advent of winter, September, 1925, proved to be unusually cool, the mean temperature for the month being 53.82 degrees. Regardless of the comparatively low mean temperature, the mercury in government instruments in Bend touched the freezing point only twice in the month.

The unusual coolness of September is attributed to the number of storms which passed over the Central Oregon country in the 30 day period. Skies were overcast by clouds for 15 days. There were 11 clear days in the month. The total precipitation for September was .55 of an inch. The warmest day of the month was September 23, when the temperature reached 83 degrees.

September weather varied from electric storms to weather which was cool enough for snow. Considerable snow fell in the mountains near Bend several times in the month.

Rum Runners' "Brains" Reported In Custody

SAN FRANCISCO, Oct. 1.—Paul Brokaw, reputed "brains" of the rum runners in the fatal Moss Landing battle with officers July 7, and an unnamed companion were arrested here early today.

The arrests were made on warrants issued in Salinas charging Brokaw, William H. Bowen, Ed Ferris and John May with the murder of Deputy Sheriff N. H. Rader. Ferris and May are in custody and Bowen still is at liberty.

Jacob Wolff, also known as White, said by federal officials to be one of the chief executives of the British Columbia-California rum smuggling ring, was in custody here today after arrest in another raid.

Soap Cakes by Thousands Left by Murdered Woman

Two of the trunks were almost filled with 2,000 cakes of individual size soap with the name of the Marth Washington hotel, New York, printed on the wrappers.

No papers of any kind which might indicate to whom the wealthy woman left her property were found.
