### 4 Indian Tribes To Get Millions

Portland, Ore., Oct. 21 (UP) — A U. S. court of claims Monday opened a hearing to determine how much money is owed four Oregon Indian tribes for land taken from them subsequent to a treaty signed in 1855.

The land involves approximately 2,770,000 acres in Coos and Lincoln counties valued between \$10,000,000 and \$15,000,000.

Fifteen hundred members of the Tillamook, Coquille, Too-Too-Toony and Chetco tribes may share in the awards, which will complete years of litigation. The U. S. supreme court in 1946 affirmed a ruling in favor of the Indians.

Clifford R. Stearns, a representative of the U. S. justice department, said the awards will be computed by setting a price on the 1855 value of the land and adding to this a fair rate of interest.

### Services Are Set For Gun Victim

Funeral services will be held at 2 p. m. Thursday from the Niswonger and Winslow chapel for Howard Leon Boggs, who was killed Sunday in a hunting accident in the vicinity of the Turnalo reservoir west of Bend, when his .22 calibre rifle was accidentally discharged. Rev. Ross Knotts, of the First Methodist church, will conduct the service, and burial will follow in the local cemetery.

Mr. Boggs, who was 41, was a carpenter by trade, and a member of the carpenter's union, local No. 41. He had been employed as a foreman by F. N. Van Matre, local building contractor, and was in charge of construction work at the Wetle building. He was a native of Marcola, and had been a resident of Bend for the past year and a half.

#### Family Survives

He leaves his wife, Dixie Boggs, four sons, one daughter, two sisters, Mrs. Elsie Serfling, Eugene, and Mrs. William Beckholdt, Portland, and three brothers, Clifford, of Portland, and Leonard and Roy, of Eugene. Children are Rolland T. and Joseph Rex, of Portland, and Larry Leon, Phillip B. and Shirley Ann, all of Bend.
