Groups Hear Speaker on UN

Combining a speaking tour with a hunting trip into the Deschutes country, George Caraker of Eugene, world traveler and lecturer, has appeared before a number of Central Oregon organizations this week.

He has been speaking on the United Nations, in connection with the 10th anniversary of the founding of the UN, to be observed nationally on Monday. Mayor Hans Sagsvold has designated Monday as United Nations day in Bend.

Caraker, speaking before the Bend Rotary club on Wednesday, declared it is necessary for the world to abolish war "or war will abolish us." He said the United Nations has the machinery to halt war, and urged that support be given to the UN.

"I am firmly convinced we have seen our last international war," Caraker declared. Caraker, whose speaking tours abroad included a visit behind the iron curtain, in East Germany, was introduced here by Mel Rogers, Rotarians' program chairman, with Ted Shoop presiding.

Caraker spoke before the Redmond Rotarians on Thursday, and was in Sisters that afternoon.

Crook County Exhibit Popular

PRINEVILLE — Potatoes, sagebrush, agates and miniature train have combined to make a star exhibit at the Pacific International Livestock exposition for Crook county, according to report from Ivan Chappell, Chappell, as manager of the chamber of commerce here, together with Gus Woods, county agricultural agent, have handled the county booth jointly during the exposition.

In his summary of the 1955 exhibit, Chappell stated that the joint action of farm and business groups in the representation through the booth was an unusual feature and attracted considerable interest.

Writing from Portland, Chappell said, "The crowds are mixed: farmers, ranchers and townpeople, with not as heavy a metropolitan audience as we had expected. . . the film 'The Prince of Peace' is being shown twice daily. The reception of the picture has been very good."

Chappell stated that Crook county 4-H and F.F.A. young people had placed in several categories. In the livestock judging team were Linda Jordan, Jack Bozarth and Bob Woods. The 4-H home economics judging contest brought the team of Judy Snyder, Carroll King, and Naty Ray from Prineville, and in the exhibition groups, Jerry Moon took an Angus steer to P.J., as did Bob Kuehl. Darrell Smith showed a Hereford steer.

The home economics team was 26th in the red ribbon group and the livestock judging placed in the white ribbon group. Moon's heavy Angus was 6th in a class of 17 grade A choice steers, and Bob Kuehl placed third in a class of 29 prime steers. Darrell Smith achieved first in the light Hereford, grade 1, choice.

Chappell stated that he was very pleased with the joint working arrangement between business and agricultural groups in presenting the county booth, and that he felt that the advantages of Crook county had been displayed to several thousand visitors. In addition to the film-showing, and the operation of the miniature train and other exhibits, Chappell also distributed thousands of leaflets during the past week extolling the virtues of Crook county.

Game Violators Top Court Docket

PRINEVILLE — The 1955 deer hunting season brought a surge of activity to the justice of peace court here during the past week, with various violations of game laws topping the heavy court docket.

Heaviest fines were levied on Hubert Rockwood, who was assessed \$50 and costs for killing a doe out of season and \$100 for the possession of untagged venison. Shooting from a public highway cost E. A. Walston \$15 plus costs. Johnny Anderson was fined \$100 for falsifying an application for a hunters license, and his license and deer tag were also confiscated.

Failure to tag a deer cost George Radford \$25, and the borrowing of a deer tag set Paul Holland's finances back by \$100. Failure to tag a deer also cost Daniel McDougal \$25 and costs, while hunting from an auto brought a fine of \$10 to Russell Kirk, Portland.

Numerous other complaints are listed in the recent justice court records. Lester Sheppard was fined \$25 for the illegal possession of untagged venison, and three men, Raymond Carrier, Leo Beirne and Norman Washburn were fined for being drunk on a public highway.

Numerous traffic violations were also listed, and one charge of assault and battery by Lucille Anspaugh, against Lorain Anspaugh, brought the issuance of a warrant. Bert McWhorter was charged with failure to stop for a school bus and fined \$25, and Virginia Hanson was fined \$10 for having four persons over the age of 12 in the front seat of a car.

Four men, of whom three were fined \$29.50 plus costs, were charged with trespassing on private property. They are Bill Hanson, Earl Smith and Darrel Miller. The fourth, Darrel Fryer, had a warrant issued for his arrest.
