Son denies that Wainwright disobeyed order

JACKSONVILLE, Fla. (UPI) — The late Gen. Jonathan M. Wainwright, the "hero of Bataan," did not disobey presidential orders when he surrendered Corregidor, his son said Monday.

Capt. and Mrs. Jonathan M. Wainwright, who live here, denied a Look magazine report of last month in which Gen. Douglas MacArthur was quoted as saying Wainwright must have been "temporarily unbalanced" when he gave up the fortress in the Philippines to the Japanese in World War II.

Instead, the son quoted the general's diary as saying refusal to surrender would have resulted in the deaths of thousands of men "whose blood would have been on my head."

The younger Wainwright quoted from his father's diary to show that orders from President Franklin D. Roosevelt were modified to allow the general to use his own discretion about surrendering.

The diary indicated, said Capt. Wainwright, that the general was not temporarily unbalanced, but a man who was "facing the facts and knowing that his commander-in-chief had assured him complete freedom of action and full confidence of his wisdom."

The diary showed, said the captain, that after Gen. Wainwright had informed the President that the Peninsula of Bataan had fallen, Roosevelt radioed instructions: "I am hopeful that you will be able to hold Corregidor. However, you are assured of complete freedom of action you may make."

STUDY PLANNED

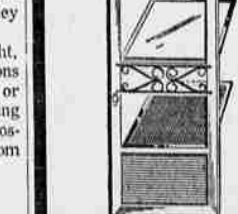
