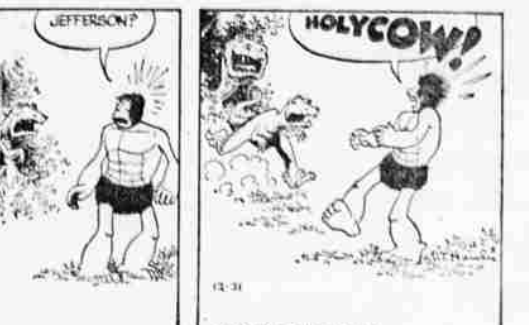

Offshore rental boost favored

SALEM (UPI) — The Oregon Land Board today upped the annual rental covering offshore oil and gas lease lands from 25 cents to 50 cents an acre.

The board also extended from two to three years the time required for the start of drilling operations once a lease is granted, and set a "first come, first served" policy on identical on-shore oil applications.

A week and a half ago state Rep. Clinton P. Haight, D-Baker, criticized the board for keeping the on-shore rental rate at 25 cents, which he contended was too low. Secretary of State Howell Appling Jr., board member, said up to now there hasn't been enough interest in oil probing in Oregon to warrant a higher rate.

However, Appling said he had proposed the higher rental before Haight issued his criticism.

The board agreed informally to sell 134 acres near Pacific City in Tillamook County to the State Highway Commission for development of a park at Nestucca Bay.

Wheeler given time for plea

CORVALLIS (UPI) — J. C. Wheeler, 45, appeared in Circuit Court Wednesday afternoon and heard a grand jury indictment read charging him with the Nov. 14 kidnapping of 8-year-old Marjorie Schubert. At the request of his attorney he was given until Dec. 27 to enter a plea.

Circuit Judge Fred McHenry denied a request of Wheeler's court-approved attorney, Robert Ringo, that bail be reduced from \$20,000 to \$5,000.
