### There are a number of reasons proposal for Dunes Park is having rough going

In a letter to the editor, published in this newspaper last week, U.S. Senator Maurine B. Neuberger lays the blame for slow progress of her bill to establish a new national park on the Oregon Dunes at the door of Gov. Mark O. Hatfield. And there are several other places where a little blame can attach.

The original proposal for a Dunes park was the brain-child of Sen. Neuberger's late husband, Richard L. Neuberger, and the National Park Service. Dick Neuberger was putting up a good fight for the park, and was making some progress. He, a Democrat like his wife, had obtained support from the Eisenhower administration for his proposal.

Then the changes started. Dick Neuberger died, was replaced on an interim basis by Hall S. Lusk, who had little interest in the proposal, and served too short a time to be effective in its behalf, regardless of his interest in the measure. John F. Kennedy was elected, and a new crew took over high-level offices in the federal government.

Neuberger's original bill was dead; a new Congress needed new legislation. His widow introduced another version. Congressman Eddie Durno now represented the district in which the park was to be located. He wanted no part of it—even though his chief campaign strategist, the late Bill Tugman, was one of the Park's strongest supporters.

One would have thought, with the park being the pet of a Democratic U.S. Senator, it would have much easier sailing under the new administration than the old, even if a Republican congressman in its own district opposed it.

But that isn't the way things go in Washington.

Senator Morse doesn't like the park proposal. And Senator Morse is a much more powerful man in Washington than he ever has been before. Apparently

### Criticism of Anderson not quite justified

he's trying to get even with anyone named Neuberger; Dick put him on a pretty tough spot a few years ago, and the Morsian memory is a long one on some matters.

Rep. Edith Green doesn't like the Neuberger bill. And she, with the possible but not probable exception of Morse, is much closer to the Kennedy administration than any other Oregon member of Congress.

Rep. Ullman, who follows Morse and Green wherever they go, doesn't like it either, and he's been no help.

Secretary of Agriculture Freeman doesn't like it, because he feels he's got to support the U.S. Forest Service, which doesn't like it.

Governor Hatfield is largely unlearned in resource, conservation, and recreation affairs. Most of this work in his administration is left up to a fellow named Dan Allen, whom one of our state's distinguished citizens recently characterized in a private conversation as a "very ordinary bureaucrat." And Allen has been opposing the park ever since it was first suggested.

Allen always says he doesn't oppose the park. He merely says he is in favor of it—provided someone makes a few changes. The changes are always ones which would be unacceptable to park supporters. The park adherents are put in the position of the fellow who is told the family will approve his marrying the girl, if he'll send her little sister through college and take little sister's husband in as a partner in his business, as soon as little sister finds a husband.

The Bulletin has supported the park since the first. We agree with Maurine that the governor's position, as outlined by Dan Allen, has been of no help to her efforts. But she's had no help, either from Durno, Morse, Green, Ullman, or the Kennedy administration.

Laying the whole blame at the governor's door is not quite right.

And this seems to be true. Every Spaniard is perfectly free, in public or in private, to agree with Franco. But he must be orderly about it. (Eugene Register-Guard)

This is certainly true in this case. Anderson has been the center of a storm in LaPine for several months. Various efforts have been made by his opponents to get even with him.

Some of the tactics which have been used were unfair, centering as they did on attempts to harm his relations with his employer, the U.S. Forest Service. Others, such as the attack upon him by retiring coop President Merritt Y. Parks, were in poor taste.

Anderson is a man of strong moral and ethical senses. It was his opinion some of the practices of the coop were open to question. He questioned them, openly. He does not deserve personal attacks for his efforts.

## Jackie's India trip has proved to be successful

WASHINGTON — Inside fact about the current glamor trip of Jacqueline Kennedy is that it got started by accident and was almost killed by her husband. He preferred that she stay at home.

What happened was that Prime Minister Nehru of India, sitting beside Mrs. Kennedy at a White House dinner last November, remarked: "You must come to India."

She replied: "I'd love to." Mrs. K thought no more about it, but Nehru did. He went home, began conferring with the U.S. Ambassador, Ken Galbraith, shortly sent a long and detailed itinerary for the First Lady. It took the President by surprise and he got on the telephone to Galbraith to discourage the trip.

Galbraith, however, is not a man easily discouraged. He was not discouraged when he first plugged for Kennedy for president, a year before the convention and when most observers didn't think JFK had a chance. And not being one who surrenders easily, Galbraith hopped on a plane and came to Washington to sell Kennedy on the Indian trip for Jackie. He succeeded.

Then President Ayub of Pakistan got into the act and invited Jackie to come to his country. The implication was that if she went to India without visiting its bitter rival, Pakistan, that candlelit dinner on the lawn at Mount Vernon would count for nothing.

The Indian attack on Goa also complicated things and delayed the trip. Finally, the President looked over Jackie's itinerary and decided it was too arduous. He trumped up the idea that she had sinus trouble, which she didn't have, and cut out several side trips.

All reports are, however, that Jackie is having a wonderful time and winning a lot of friends for the USA, in an area where we need friends and where Khrushchev and Bulganin once spent two weeks on a very successful bar-storming trip. Maybe Mrs. Kennedy should travel more.

Te-Aviv to Albany??

The Republicans have quietly started grooming an eventual candidate for governor of New York in a manner that confirms the suspicion of Sen. Bill Fulbright of Arkansas.

Two years ago when Ogden Reid of the famous New York Herald Tribune family was up for confirmation as ambassador to Israel, Senator Fulbright opposed him on the grounds that he was using the Israeli ambassadorship as a stepping stone to Albany.

The diplomatic post in Israel would help him win the big Jewish vote in running for governor of New York, Fulbright suspected.

Reid, however, denied this. He said he had no political ambitions and no foreseeable plans to run for governor of New York or mayor of New York or, he implied, any other New York political post.

But up in Westchester county the other day, Edwin Michaelian, Republican boss of the county, quietly served notice on GOP Congressman Edwin B. Dooley that he should "move over" and let Ogden Reid run instead. He said Dooley could become chairman of the New York State Fitness Program under Rockefeller at \$18,000 a year.

Dooley is an unimpressive, conscientious Republican who was an all-America footballer at Dartmouth, wrote sports for the old New York Sun, even wrote a football novel, "Under the Goal Posts." He has served faithfully in Congress for six years, but now the party bosses say he should move over in favor of young Reid. So far Dooley has declined.

It looks as if Senator Fulbright was right after all.

Is Hitlerism Coming Back?

For the first time since the war, a meeting is being held on American soil where the revision of German borders along Hitler lines is due for discussion. The meeting being held in Chicago this week has already raised alarms in Poland and Czechoslovakia partly because one of the leading West German revisionists, Bundestag member Weufel Jaksch, will be one of the speakers.

Jaksch is one of the most active German leaders in demanding that the Sudetenland be taken away from Czechoslovakia and given to Germany, also that upper Silesia be taken from Poland and returned to Germany.

It was the seizure of the Sudetenland by Hitler in 1938 that raised the first signal that World War II was imminent, and it was the seizure of Poland by Hitler that precipitated World War II.

The Chicago meeting is held under the auspices of the Foundation of Foreign Affairs and the Herder Institute of Marburg, West Germany, for the purpose of discussing East European affairs.

**B-70 Lobbying**  
 Both Secretary of Defense Robert McNamara and Congressman Carl Vinson of Georgia have been wooing supporters behind the scenes in their battle as to whether Congress should or should not vote money for the B-70 which the Kennedy administration says it doesn't need.

McNamara, age 45, went around to see crusty Congressman Clarence Cannon of Missouri, chairman of the Appropriations Committee, to try to get him to block the money. The 83-year-old Cannon was inclined to stick with his 79-year-old colleague from Georgia.

Vinson meanwhile went around to see southern friends on his own Armed Services Committee, and at a two-hour closed-door argument over the B-70 it appeared that he had won some support from Ed Hebert of Louisiana and Mendel Rivers of South Carolina.

So many Democrats cross-examined McNamara, however, that GOP Congressman Leon Gavin of Pennsylvania demanded to know if Vinson planned to confine the questioning to Democrats and "cut off Republicans." He asked McNamara: "Do you really have any plans to make use of this additional money?"

"Quite frankly, we do not anticipate any need for the additional amount," said McNamara. "In that case, the House Appropriations Committee might not appropriate the money, even if we authorized it," suggested Gavin. "It's happened before. What makes you think they won't do it to us again, Mr. Chairman?"

"I'm not overlooking that possibility," replied the wily Vinson who did not let on that Appropriations Chairman Cannon was on his side. "However, that's their responsibility. We're doing our job here. Regardless of what the secretary says, I'm still convinced that missiles aren't the whole answer to our future defense. The manned bomber will continue to play a vital role."

### Action against police brutality being sought

WASHINGTON (UPI) — Justice Department officials said today their latest civil rights proposal would make it easier to convict policemen guilty of brutality and third-degree methods of interrogation.

Atty. Gen. Robert F. Kennedy asked Congress Tuesday to close loopholes in the present federal ban on beatings imposed on prisoners in the guise of law enforcement.

In a message sent to congressional leaders, Kennedy also appealed for stiffer fines and jail sentences for anyone convicted of such offenses.

**Get Three Convictions**  
 Burke Marshall, assistant attorney general in charge of the civil rights division, said only three convictions for police brutality have been obtained during 12 prosecutions in the two years ending last June 30. Four cases are still pending in the courts.

Yet the department received more than 1,000 complaints alleging police mistreatment or coerced confessions during this period, Marshall said. Approval of the new proposal would "ease the burden of proof" in such cases, he said.

Kennedy told Congress that the present federal law is too vague and the penalties are too inadequate for cases in which victims of brutality receive severe injuries or die.

Under Supreme Court rulings, he added, police accused of beatings or forcing confessions often are successful in pleading that they did not realize a prisoner's constitutional guarantees were being violated.

### Rangeland improvement plan told

PORTLAND (UPI) — A seven-year program to improve South-east Oregon rangelands was announced here Tuesday by Karl S. Landstrom, national director of the Bureau of Land Management.

Landstrom announced plans to spend \$16.5 million on the 6 1/2 million acre Vale Project in Malheur County. The project also includes small portions of Harney and Grant Counties.

Landstrom said management practices will be intensified on federal, state and private lands within the project. The government will offer ranchers unused land for areas under treatment to prevent reduction in the number of livestock being grazed.

Russell M. Getty, BLM state director, said 73 per cent of the four million acres of BLM land in the Vale district supports only a fraction of the vegetative cover that once existed, and 32 per cent of the land is deteriorating under present use.

Getty said the land can be rehabilitated by reseeding, brush eradication, erosion control, development of water supplies and intensive management of livestock.

The Vale Project will be used as a pilot program to demonstrate what can be done in other parts of Eastern Oregon, Idaho, Nevada, and parts of Utah and California, Landstrom said.

### Ship strike in 6th day

SAN FRANCISCO (UPI) — The West Coast maritime strike moved into its sixth day today with no indication of a settlement, although both sides in the dispute have agreed to concessions on some strike issues.

Three striking Maritime unions — sailors, firemen and cooks and stewards — agreed Tuesday to permit immediate sailing of two vessels with military cargo, including 1,500 tons of nuclear test material for Christmas Island.

The agreement between the unions and the Pacific Maritime Association, representing the employers, also will allow passenger ships at Honolulu to return with their passengers to West Coast ports.

However, there were no negotiations scheduled between the PMA and the striking unions which would bring an end to the walk-out. When negotiations broke down, the unions announced that the parties were still \$6 million apart on a new three-year contract.

The strike thus far has idled about 30 vessels, including four passenger liners in San Francisco.

### Hatfield seeks cooperation on dunes plan

SALEM (UPI) — Gov. Mark Hatfield said Tuesday Sen. Maurine Neuberger, D-Ore., "needs to clarify her stand on what remains to be compromised" in her legislation to create a national recreation area in the Oregon Dunes.

Hatfield said Mrs. Neuberger still hasn't agreed to changes which would give the state first say over fish and game resources, and oil and mineral rights within the proposed park.

Hatfield said he favors a dunes park development if the state has such guarantees.

The late Sen. Richard L. Neuberger, D-Ore., was cooperating with the state on such matters, Hatfield said, but state officials are not getting "this kind of cooperation from the second Sen. Neuberger."

Hatfield was asked at his news conference why his "Decade of Development" report on natural resources doesn't mention the dunes. He explained that specific developments are mentioned by name in the report.

Hatfield noted, however, that the report urges the federal government to spend more money on recreational development in Oregon, and this would include the dunes.

### Approval given airport money

SEASIDE (UPI)—A request for \$3,000 to assist in runway reconstruction at the Lakeview Airport was approved Tuesday at a meeting of the State Board of Aeronautics here.

The city of Lakeview and Lake County had asked for the money, which will be added to federal funds.

The board also reviewed its requests for federal funds to assist in building two new airports at Brookings and Cottage Grove and improving fields at Seaside and Hermiston.

### Eichmann put in special cell

JERUSALEM, Israel (UPI) — Adolf Eichmann, sentenced to hang for the mass murder of millions of Jews during World War II, was transferred early today from his prison cell near Tel Aviv to a special cell in the Beit Haam Court building here.

The former Nazi officer's appeal of his death sentence will be heard by an Israeli court Thursday.

### Plane quest is cut back

CLARK AFB, Philippines (UPI) — A few weary flight crews today kept up the almost hopeless task of searching for a Flying Tiger airliner that vanished last week with 107 persons aboard.

Planes and crews have been flying as long as 12 hours daily and only six planes from Clark Field took to the air this morning. The Air Force said it was forced to cut back on the search because of crew fatigue and the need for aircraft maintenance.

Five days of intensive search had extended crews and their planes to the limits of safety as they scoured 240,000 square miles of some of the loneliest expanses of ocean in the world.
