The Cold Canal Vegetation Project Environment Assessment and Draft Decision Notice have been completed and mailed out on September 16th, 2015 to those who previously requested to be included on the project mailing list or submitted specific written comments related to the project. The Cold Canal Vegetation project proposes to thin trees and/or prescribe burn on 9,519 acres in the Cold Canal area. The purposes of the project are to manage fuel levels on National Forest System lands by minimizing the risks of future highseverity fires, particularly within the wildland urban interface, and to increase the forest's resilience to natural disturbance.
