• A fire at the Herb Owens farm four miles east of Joseph completely destroyed a large barn and all of its contents on Friday, Jan. 7. The fire apparently started about 2pm while the Owens were shopping in town and was not discovered until it "blew up" and was beyond the point of controlling. The fire was discovered by Harold Klages, a neighbor.

• A school bus driven by Keith Moffit, and a one-ton flatbed truck driven by Don Davis, side-swiped on an ice-covered turn on the Crow Creek road about 25 miles northeast of Enterprise last Thursday morning about 7:45. The school bus had not picked up any children at the time of the accident. There appeared to be no injuries.
