CW-111 filed by Ken & Bobbie Baker, 81705 Hwy 82, Wallowa, OR 97885, and Perry Johnston, 81703 Hwy 82, Wallowa, OR 97885, proposes to convert approx. 235.6 acres from flood irrigation to high efficiency pivot irrigation. The project on the Lostine (aka South Fork Wallowa) is expected to conserve approx. 1.98 cubic feet per second (CFS) and 353.4 acre-feet (AF) as follows:
