Budget of nearly \$6.7M on track for approval

ENTERPRISE — A budget of nearly \$6.7 million was approved by the Budget Committee for the city of Enterprise for fiscal year 2021-22 during a budget meeting held Wednesday, May 12, at City Hall.

The new budget is up from last year's budget of \$6.25 million and will have more than \$1.7 million designated to the general fund.

The committee is made up of Mayor Ashley Sullivan, the six City Council members and seven members of the public at large. Committee member John Lawrence was appointed as chairman of the committee. A budget hearing is scheduled for June 21. It must be approved by the council by June 30.

The largest concern appeared in the sewer fund, said Lacey McQuead, city administrator and budget officer.

The fund, which is funded solely by user fees, does have a 1.5% increase in revenues coming in July based on a February 2020 resolution approved by the City

However, McQuead and Public Works Director Ronnie Neil are concerned as the costs of materials and services are on the rise, in addition to the extra plant operator expected to be hired. It is expected the rate increase will not be sufficient, as there is less than \$315,000 for equipment replacement and plant improvements and the city still owes more than \$4 million in loans for the plant.

The city plans to hire a second person qualified to operate the plant. McQuead said the Oregon Department of Environmental Quality requires someone with a high school diploma or its equivayears) experience in order to receive a Level 3 Operating Certificate, as required for the Enterprise plant. After budget is approved, city plans to advertise for the new position.

As McQuead stated in the budget proposal, the city's current sewer plant operator is years away from retirement, but it takes eight years for a person to be certified to run the plant.

"With our current sewer plant operator 20 years in, hiring at this point is the only option we have," she said.

McQuead asked the committee for recommendations on how to improve the Sewer Fund.

"If we do not make some changes now, this fund will fail," she said.

In her budget message, McQuead also envisioned "encouraging changes" as the COVID-19 pandemic winds down.

"While COVID-19 hit hard, we sustained with limited interruptions and have successfully moved forward," she said in her message. "We know there is more possibility for change, including implementation of more guidelines, all of which we will face as they come. In the meantime, we are excited for the 2021-22 fiscal year and the good that's coming to the future of Enterprise."

Federal funds likely to help

federal expected from the American Rescue Plan that President Joe Biden signed March 11 are likely to help. The city was told it would receive \$410,000 under the plan half this year and half next year. But guidelines on how the money can be spent are still uncertain.

In the water fund, by the end of April, the city had only

lent plus 16,640 hours (eight spent 77.2% of the anticipated expenditures, so there is a considerable increase in the available cash on hand. The proposed budget is designating \$75,000 for the water fund that is expected from the ARP money. No solid plans exist to spend the ARP funds, so a resolution will be required to do so.

Also, the city is budgeting \$50,000 in the general fund for the anticipated ARP funding. There are currently no plans to spend these funds, so a resolution will be required before processing any payments.

In the state street tax, the pandemic has affected driving behavior, with highway revenues for the 2019-20 fiscal year coming in about 5% below projections. The estimates for the 2020-21 were revised downward by slightly more than 12%. The 2021-22 projections are based on assumptions by the Oregon Department of Transportation that a vaccine will get more widespread distribution this summer and fall, which will encourage more people to travel.

In the Motel Tax Fund, the city receives a 3% motel tax directly from motels, bed & breakfasts, and Airbnbs. The city also receives a percentage of Wallowa County's 5% motel tax.

The city transfers funds to the general fund for tourism-related activities, park maintenance, police detail for events and fire department services for increased motor vehicle accidents in the summer months. This year, the city will transfer \$30,000 to the general fund. Of that amount, \$15,000 will go toward Police Department overtime/event coverage, \$5,000 will go toward Fire Department response and \$10,000 will be allocated to park maintenance and improvements.
