The hatchery grounds will be beautiful and made into a park. The ponds will be available for bathing in the summer and skating in the

winter. In order that everybody may have a square deal, the fair management has decided that the sale of box seats shall begin at 2pm on October 1 and that seats will be sold in the order in which people come.

From the large ranch of Charles Down on Upper Prairie creek comes a report of a heavy yield of wheat. The grain threshed 56 bushels to the acre. It has been irrigated in other years, but had no water at all this year.


