NOTICE IS GIVEN, the Wallowa County Board of Commissioners will be conducting a public hearing Wednesday, July 20, 2022, at 10:30 a.m. in the Thornton Conference Room of the Wallowa County Courthouse; located at 101 S River St, Enterprise, Oregon 97828.

This public hearing will be to consider the appeal (**Board of Commissioners Appeal #22-02**) submitted by Andy McKee on behalf of the appellant, McKee Bros. Investments, LLC. The appellant is appealing a decision made by the Wallowa County Planning Commission to deny the issuance of Conditional Use Permit CUP#22-05 for a Home-based Occupation in the form of a Bed and Breakfast in the Exclusive Farm Use (EFU) zone. The property in question is described as Township 02 South, Range 45 E, Section 19, and Tax Lot 700. It is more commonly known as 83334 West Lewis Lane, Joseph, Oregon 97846 and consists of approximately 120.65 acres.

These matters will be reviewed for conformance to the WCCLUP and WCLDO 5, 7, 9, 15, 25, 35, and 36, and any other applicable goal, regulation or ordinance of Wallowa County or the State of Oregon.
