CW-129 filed by Rocking M Cattle Company, 70208 Warnock Rd, Wallowa, OR 97885, proposes to convert approx. 72.29 acres from flood irrigation to high efficiency pivot irrigation under Certificate 3162 with an 1883 priority from the South Fork of Wallowa River. The project on the Lostine (aka South Fork Wallowa) is expected to conserve approx. 144.58 acre-feet (AF).

The Applicant proposes 100% of the conserved water (144.58 AF) be allocated to the state for in-stream purposes.
