

Veteran Indian Fighter Seeks To Become Citizen

Dallas, Or., Feb. 21.—Simon Christanson, a veteran of the Sioux Indian war in South Dakota in the year 1890 and 1891, appeared at the court house Saturday morning and took out his third declaration of intention. Mr. Christanson is 52 years of age and is decidedly active and brawny. He first declared his intention to become a citizen in Mason City, Iowa, in 1898, after his arrival from arrival from Denmark but did not proceed with the petition of naturalization.

In 1904, at Newcastle, Wyoming, he again declared his intention to become a citizen but did not proceed further.

He fought in the battle of Wounded Knee at the time Sitting Bull was killed and he received several government mentions for his bravery and conduct as a soldier.

He is now working for the Southern Pacific at Falls City and is still enjoying single blessedness. He has never been married and says that he intends to remain an old bachelor as he is so old and unchangeable that it would be unsatisfactory for him to do otherwise.
