Bids Are Asked On Road Bridges

The following bridges will be among the projects for which sealed bids will be received by the state highway commission at the Multnomah county court house on July 25, according to a statement given out by Roy A. Klein, secretary to the commission, today:

Union county—One concrete span over Wolf creek, two miles north of Powder river, and one concrete culvert over Jimmy creek three miles north of North Powder.

Wallowa county—Several small timber trestle bridges on Joseph highway at La Grande. Seven frame trestle spans over Fair creek on Joseph highway.

Washington county—Repairs to existing bridge on Tualatin valley highway, three-quarters mile south of Forest Grove.

Horticulturists of Oregon, Washington and Idaho will meet at Hood River, July 26 to 29, and will effect a permanent organization.

Realty Board Takes Double Page Spread

Portraying the beauty spots of Salem and the surrounding territory as a land of diversified farming and opportunity, the Marion County Realtors' association has taken a double page advertisement in the national convention number of the Northwest Real Estate Journal, which will be presented to all the 5000 delegates at the national convention now being held in Chicago.

The picture of Salem is taken from some point near the corner of High and Court street looking toward the court house and state capitol, showing the beautiful grounds and shrubbery of that part of the city.

In addition to the large cut of Salem are two small ones giving an idea of the productiveness of Marion county farm lands. The subject matter of the advertisement tells of the additional industries besides agriculture which the city possesses, the educational facilities surrounding this community, as well as the road program of the county and the city's location on the important Pacific highway. The names of the 48 members of the realty board are also included in the page.

Other cities of the northwest have further added to the fame of the northwest. Portland, Seattle, Tacoma, Spokane, Vancouver, Washington, as well as several cities in Idaho have taken space in the periodical which perhaps gives the development of the northwest a better showing than has been its fortune to receive for some time.

New Implement Rates Are Filed

Reductions of from 15 to 36 cents per hundred pounds on all freight rates covering trans-continental shipments of a 24,000 pound minimum of agricultural implements will result from a new tariff, filed with the public service commission today, to become effective August 10.

The new tariff, filed by the trans-continental freight bureau establishes what is called a mixed carload rating on all agricultural implements. In the past all rates applied only to straight carload shipments.

Oil Operations at Tampico To Be Resumed

Tampico, July 13.—Resumption of operations in the Tampico district by oil companies is expected in official circles here. Drilling permits are being granted daily by the government and some companies have continued work during the past troublesome months without discharging a single man.

It is reported that the Huasteca company has ordered its tankers to be made ready to resume operations in the near future. The Texas company intends to load eight tankers this week.
